### President's Report – 6 April 2018

At last year's AGM, I made a commitment to develop a five-year strategic plan for the Association. It will take time and effort to develop and coordinate this plan so that it is integrated with the serving component and the Foundation and it is still a work in progress. One of my top priorities for 2018 will be to establish a Veterans and Family Support Committee at the National level. This committee would be tasked to oversee the Volunteer Patricia Program (VPP), determine how that Association can best support Veterans and Families, establish and maintain contact with the families of the fallen and amend existing policies to ensure support to Veterans and Families is a high priority for all.

The Association has made outstanding headway with respect to Mental Health and Suicide Awareness or what I call the "Healthy Soldier - Healthy Veteran". Mental Health is an extremely complicated issue and I do not intend to create a new approach. Rather, we must partner with others and raise Mental Health awareness within the Association and retired military community. We have successfully conducted two workshops in Edmonton and Victoria, with three more planned for Sep and Oct 2018. The VPP / Mental Health and Suicide Awareness Workshop article will provide you with more details. My biggest concern is that so far, no retired or released Patricias under the age of 55 has participated in the workshops to date. The current generation must get involved in helping their peers.

We must encourage recently released or retired Patricias to join the Association. The Association provides a free three-year membership for soldiers releasing after 1 May 2016 and very few have taken advantage of this offer. I can understand the reluctance of those who served 25 or more years; who want a break from the military and are concerned that they will be asked to continue in a leadership role. However, the PPCLI Association needs their leadership, experience and knowledge of the gaps so that we can help younger veterans. LGen (Ret'd) Walter Semianiw made it very clear that from VETS Canada's perspective, medically released Combat Arms Sgts and below with less than 10 years of service are the group that needs the most help. Very few, if any of these individuals are joining the Association upon release despite the offer of a three-year free membership. Many of us know individuals who have released and not joined the Association. I ask everyone to reach out and encourage them to join.

Transition to a civilian career, is an area where I believe that Association members can help. There are many Patricias out there who are now well established in a second career. How many are willing to mentor or provide advice to a young soldier who is in the process of leaving the military? Herb Kenny, President of the Edmonton Branch, has established a process where a volunteer will help releasing soldiers convert their military career into a resume. We need to build on this and put a plan in place where the Association can help with the transition. Once again, my request is that you get involved, help others so they will have a successful second career.

The Association is improving communications with the serving community and released or retired members. However, the majority still have no concept of what the Association does or how we help.

### 10 Reasons to join the PPCLI Association

- 1. **Once a Patricia, Always a Patricia**. We are all part of this Regimental family. Regardless of your background, your length of service or your 'next bound'. You will always be a Patricia and welcome in The Association. Did you know that the Association offers a free three-year National membership for those released or retired since April 2016?
- 2. **Volunteer Patricia Program (VPP).** The VPP supports serving, released and retired Patricia's and their families who need assistance. Since June 2017, they have helped 18 individuals who were either homeless, dealing with extensive medical bills, needed help travelling to medical appointments or needed a fire team partner. We need more VPP supporters who have the time and energy to help others.
- 3. **Mental Health and Suicide Awareness**. The Association has been aggressively promoting Mental Health and Suicide Awareness. The 1<sup>st</sup> workshop was conducted in Edmonton in Oct 17, the 2<sup>nd</sup> in Victoria 23 23 Mar 18 and three additional workshops are planned for Sep and Oct 18. Get involved and attend a workshop so that you can help your brothers and sisters. Saving even one life makes it all worthwhile.
- 4. **Education**. In 2018, the Association will award 11 Student Bursaries for a total of \$21,000. This program is available to serving, released and retired Patricia's, including wives, children and grandchildren. Applications must be submitted by 15 July of each year
- 5. **Support to Veterans and Families**. In 2018 and beyond, the Association will provide financial support to MFRCs Edmonton, Calgary and Shilo, Col Belchner Centre Calgary, Kipness Centre for Veterans Edmonton and Valour Place Edmonton.
- 6. **Cadets**. Our 'Farm Team.' Young people who work hard to perpetuate our Regiment. The Association provides Regimental hat badges, shoulder flashes and financial support to PPCLI Affiliated Cadet Corps. Cadets will benefit from your mentorship to the youngest members of the Regimental Family
- 7. **Regimental History and Heritage**. Memorials to the fallen are sacred and must be preserved. As part of the 100<sup>th</sup>, the Association raised \$300,000 for Patricia Park in Edmonton, completely refurbished Frezenberg at a cost of \$65,000 and Lansdowne, Ottawa at \$25,000. Designed and paid for the Memorial Baton. The Association is responsible for maintaining Frezenberg, Lansdowne and Patricia Park and other Regimental Memorials.
- 8. **Regimental Museum**. The Museum preserves our achievements and history and it provides outreach into the civilian community. They depend on The Association for funding and volunteers. The Association's funding is important supporting the museum's operations and outreach.
- 9. **Fundraising**. The Association cannot accomplish the above without money. Every 18 months, the Calgary Branch volunteers at a Casino which raises between \$60-80,000. The average return on Hamilton Gault Memorial Fund investments is \$25,000 per year and a further \$10-20,000 is donated by Association members. With more support, we can have an even greater impact.
- 10. **Regimental Influence**. There are 14 Branches across Canada and each hold a number of social activities based on the desires of their membership. They keep the Regimental spirit alive and often assist individuals within their local area. There is no rank in the Association. If a retired or released Pte/Cpl/MCpl, etc.. does not like the way things are going they can voice their opinion and be heard. Get involved in a Branch and help chart the Way Ahead for the Branch or Association. The Association is not just for 'Old Geezers.' It is your Association get involved and steer it towards activities that interest you.

Serving members can join and those long retired are also welcome! National dues are \$25.00 a year and cover the costs of operating the Association. We work behind the scenes, building and protecting your legacy so that the serving component can get on with making history.

### Volunteer Patricia Program Mental Health and Suicide Awareness

Since June 2017, Dave Pentney has been the VPP Facilitator and the main driving force behind the support that we have been providing to various veterans in need. As of 4 April 2018, VPP has helped 18 veterans. Only two of these individuals were Association members and in fact there was also an Engineer, Signaler and Admin Clerk in the group. The requests for assistance involved everything from attempted suicide, homelessness, financial distress, assistance with VAC claims to Social Support.

Many of these cases were referred to us by VETS Canada. Both the Regimental Veterans Care Cell (RVC) and VPP have a very good relationship with VETS Canada. Cases initiated by VETS Canada are generally about contacting the veteran and providing moral support. VETS Canada does most of the detailed work in physically getting the individual off the streets and into suitable, if temporary, accommodation. Two cases of these involved non-Patricias (one Sigs and the other CME). In both instances we were able to facilitate a hand-over to their respective Associations.

Most cases have been a relatively simple matter of touching base with the veteran, acting as a point of contact and letting them know that they are not alone while providing limited assistance. There have been a few that are more complex. In one case, a retired Patricia did not have sufficient funds for medical treatment for his wife. RHQ/RVC took the lead in coordinating funding through the Royal Canadian Legion, the Soldier On Trust and a PPCLI Benevolent Fund Grant. VPP acted as the point of contact with the veteran. In another case, we were advised by another agency that a former Patricia, undergoing PTSD treatment needed a serviceable vehicle in order to attend treatment sessions. This case was referred to the local branch. This was resolved when an anonymous donor agreed to pay for a replacement vehicle – an unbelievably generous act.

More than 40% of the cases dealt with to date have been outside the catchment area of an established branch. In these cases, Dave has contacted an Association member, most often an E-Member, and sought their assistance. In all cases they have responded positively, if they were in the area, and have made the first contact with the veteran, then reporting back to Dave while continuing to follow-up as required

The VVP network is growing and via the Mental Health and Suicide Awareness workshops we have trained 6 retired and 4 serving Patricias in Edmonton and another 12 retired Patricias in BC. The workshops have been very successful and the Naval participants in Victoria were very supportive and appreciative of being included. The workshops consist of a two-day VAC Mental Health First Aid course for Veterans and a third day which focuses on the duties and responsibilities of a Branch VPP coordinator. For the third day, there are a series of guest speakers from VETS Canada, Operational Stress Injury Social Support (OSISS), SISIP, Soldier ON, Legion Service Officer and VAC. These speakers provide an overview of how they help veterans and how they can be contacted. It is not our intent to create a new system. It is critical that the Branch VPP coordinators understand who is available to assist veterans and how to contact the agencies in their region. We also reviewed several case studies based on the veterans we have helped since June 2017. The intent was to highlight what worked well and where we need to improve our support to veterans.

It was stressed during the workshops that we are all volunteers and are not Mental Health experts. Our capacity to affect change is limited and we must deliver on what we promise. We cannot work in isolation and need to develop partnerships with like-minded agencies that currently exist to assist veterans. We need a pool of trained volunteers across Canada. To accomplish this, we are planning to conduct three workshops in Sep and Oct. The intent is to bring Patricias in from outside the local area and from adjacent Provinces. It is estimated that it will cost up to \$30,000 for the three workshops, including the one that was

just conducted in Victoria. This is primarily due to travel and accommodation costs. In order to alleviate this cost an application has been made to True Patriot Love for a grant of \$24,000. TPL has acknowledged receiving the request and it is believed that we have a very good chance of receiving some or all of the funds requested.

The planned workshops are:

Gagetown 7-9 September with participants from Nfld, NS, PEI, Quebec and NB; Calgary 21 -23 September with participants from Alberta, Man, Sask and Yellowknife; and Kingston 19 – 21 October with participants from Ontario and Quebec.

By the end of October, we should have up 60 trained VPP coordinators across Canada. There is little doubt that requests for assistance will increase as more as more people become aware of what the Association is doing to help Veterans. Several other Associations have been approached with respect to adopting the PPCLI Association Mental Health and Suicide Awareness Workshop model. The Association has put in place an action plan because of the workshop that was conducted at the 2017 National AGM. Mental Health and Suicide Awareness is a complicated issue to address and as an Association we are setting the example for others.

On 6 April, Dr Alexander Heber, Chief Psychiatrist for VAC, requested that the PPCLI Association participate in a one-day roundtable discussion to be held in Ottawa on 23 May. The roundtable will discuss whole-of-community approaches for preventing suicide with representatives from researchers, clinicians, front-line workers and various veteran Associations. The work that the PPCLI Association is doing with respect to Mental Health and Suicide Awareness is being observed and followed at senior levels within VAC.

We are making a difference in the lives of veterans and if we save only one life it is worth the effort.

### 2017 PPCLI Student Bursary Report

### General

The selection board sat in Wainwright, AB on 27 July 2017. The board consisted of Michael Austdal, Director Bursaries, Jim Croll, Association Treasurer, Major Tony Ross, 3CDTC and MWO Kevin Littlejohn, CMTC.

There were 25 applicants, 11 were awarded bursaries for a total of \$17,000. This was the greatest number of applications to date and all the candidates were well qualified. Three of the bursaries are awarded in the name of Association branches that donated money directly to the program. One was awarded in the name of the Association and the remainder in the name of well-known Patricias. \$17,000 is the largest cumulative amount awarded for bursaries and \$2,500 is the largest individual award to date. Our aim is to eventually reach \$25,000.

### STUDENT BURSARY TERMS OF REFERENCE

- 1. In 2018, the HGMF Board of Trustees intends to award 11 bursaries for a total of \$21,000:
  - a. Medak Pocket \$3,000;
  - b. Pte John Prezenski \$2,500;
  - c. LCol AG Pearson, MC, DCM \$2,500;
  - d. Capt Jim Decoste \$2,000;
  - e. Lady Patricia \$2,000;
  - f. Cpl Crawford Dover \$1,500;
  - g. Hamilton Gault \$1,500;
  - h. Hamilton Gault \$1,500;
  - i. Hamilton Gault \$1,500;
  - j. Hamilton Gault \$1,500; and
  - k. Hamilton Gault \$1,500;
- 2. <u>Eligibility</u>. To be eligible for a PPCLI Association Student Bursary, you must be a serving, former or retired member of the Regiment or their spouse, child or grandchild or a member of a PPCLI Cadet Corps. Applicants for a PPCLI Association Student Bursary must be enrolled in an accredited post-secondary institution.
- 3. <u>Post-Secondary Institutions</u>. An eligible educational institution is defined as any accredited degree or diploma granting post-secondary institution (i.e. university, community college, or technical school), located anywhere in the world. (Note that part-time, correspondence, or night school programs are not eligible for subsidization).
- 4. <u>Application Procedure</u>. Applications are available through the Association Bursary Coordinator at (780) 261-0300 or <u>maustdal@hotmail.ca</u> or on the Association website <a href="http://ppcliassoc.ca/">http://ppcliassoc.ca/</a>. Applications must be received, no later than 15 July, by the PPCLI Association Bursary Coordinator:

- 5. <u>Obligation</u>. The bursary recipient(s) must enter the post-secondary institution of his/her choice in the year of application and maintain a course of study leading to a diploma or degree. **Part-time, correspondence, or evening courses are not admissible.** It is the obligation of the recipient to maintain satisfactory progress and to submit the Certification Form to the Association Bursary Coordinator on completion of the year. A Statement of Understanding must be completed prior to the first semester.
- 6. <u>Selection</u>. The HGMF Board of Trustees will use the selection criteria, based on the applicants' submission as outlined at Appendix 4 to prioritize applicants

### **NOTES TO AGM RESOLUTION 01-18**

The Executive of the Association thanks all who participated in the recent review of PPCLI Association By-law No.1. All the suggestions made by Directors and Members have been considered against the terms of the Canada Not-for-profit Act (NFP Act), which provides regulatory guidance for all Not-for-profit Corporations registered in Canada. Most of the suggestions have been incorporated in the amendment: the rationale for those not accepted at this time has been given the Director or Member who made the suggestion.

As well, a review of amendments to the NFP Act and its accompanying Regulations has been conducted, and the single item which has an impact on the Association has been incorporated in the Resolution.

This note covers the resultant amendment, which follows. In summary, the amendment includes:

- New definitions for "e-member" and for "spousal or partner member", to account for the fact that the *Patrician* is no longer automatically mailed to members;
- Updating and revision to the rules governing Board and Member's Meetings concerning mailed-in ballots, and meetings with both Directors/Members present and Directors/Members who are participating by electronic means, to reflect the technical advances made since 2014;
- Updating the rules concerning non-payment of dues to allow for a suspension of membership after three months, followed by termination after 12 months rather than the more draconian termination after three months in arrears:
- Deletion of the list of Standing Committees, the creation and amendment of which is the prerogative to the Board of Directors, and thus should not need an amendment to the By-law every time a change is made:
- A revision of the HGMF Board of Trustees, to include the Past President, and the Chair of the Finance Committee as Advisors to the Board; and
- A change in the notification time for Board Meetings to five from seven days.

It should be noted that this Resolution, as it has been approved by the Board of Directors, cannot be subject to amendment, but rather is an "up or down vote" of confirmation.

### **RESOLUTION 01-18**

### A Resolution of the AGM, amending PPCLI Association By-law No.1

WHEREAS By-law Number One of the PPCLI Association was approved by Members at the Annual General meeting held in Edmonton AB on 08 August 2014, and came into effect on 22 October 2014, the date the Articles of Continuation were approved by Industry Canada/Corporations Canada;

AND WHEREAS it has been over three years since By-law No. 1 took effect, the Board of Directors decided to give Directors and Members the opportunity to review and suggest revisions to By-law No.1;

AND WHEREAS after the opportunity to review the By-law, it was noted by Directors and Members that there were a number of areas which required updating and amendment;

AND WHEREAS in accordance with Article 11.01 of these By-laws, an amendment to the By-law No. 1 is made by Resolution or Special Resolution of the Board of Directors and confirmed by similar Resolution or Special Resolution at the following AGM of Members of the Association;

WHEREAS none of the items to be considered for amendment at this time are such that a Special Resolution is necessary;

AND WHEREAS the Board of Directors, at their Meeting on 11 April 2018, considered and passed BoD Resolution 01-18, the second Amendment to By-law No.1, the terms of which are presented to Members at the 2018 AGM for consideration and confirmation.

### BE IT RESOLVED THAT:

PPCLI Association By-law Number One, as amended, be further amended as follows:

1. Replace the content of sub-paragraph 1.02. k, with revised wording:

"k. "e-member" is not a class of Member, but rather the description of a Member or Supporting Member who has agreed that all correspondence

with the Association will be by electronic means, and who thus will not receive any printed material or publications from the Association by mail and/or in hard copy. An e-member may be a Member of a Branch, although this would be unusual.

AL2"

- 2. Replace the content of sub-paragraph 1.02. s, with revised wording:
  - "s. "Spousal or partner member" is not a class of Member, but rather the description of an individual who is qualified to become a Member as a result of their relationship to another Member. (See paragraph 2.02 2.a.(1).(c) below). A spousal or partner member may be a Member of a Branch or may be an e-member.

    AL2"
- 3. Insert a new sub-paragraph, 2.04. 6:

- "6. Provided Members not present may access a meeting electronically, by telephone or other communications method, and there is a method and means of receiving, authenticating and tabulating votes cast through these means, it is not necessary that the Chair of the Meeting provide for absentee voting by means of mailed-in ballots. Such absentee votes by electronic means shall be collected, counted and reported as if the Member were present at the Meeting.

- 4. Delete paragraph 3.01 Membership Dues, and insert a new paragraph 3.01 with same title:

### **"3.01 Membership Dues**

- 1. On the recommendation of the Board of Directors, the Members, by Ordinary Resolution, will establish the amount of annual dues for Members, Supporting Members, spousal or partner members, and e-members. Annual dues may be waived for those Members who have prepaid for Life Memberships, for those previously admitted as Honorary Members, or for other Members or Supporting Members recommended by the Board for approval by Ordinary Resolution at an AGM.
- 2. Members shall be notified, in writing or by other means, of the amount of annual membership dues payable by them. If applicable dues are not paid within three calendar months of the renewal date, then the Secretary or Branch President, as applicable, shall suspend all membership privileges, including voting, until the dues owing are paid in full. If the Member, Supporting Member, spousal or partner member, or e-member has not paid in full the dues owing by 31 December of the membership year, then the that member shall be considered to be in default, and their membership in the Association will automatically be terminated.

- 5. Delete paragraph 4.09 Meeting Held Entirely by Electronic Means, and insert a new paragraph, 4.09 Meeting Held Wholly or Partially by Electronic Means:

### **"4.09 Meeting Held Wholly or Partially by Electronic Means**

AL<sub>2</sub>

- 1. If the Directors or Members of the Association call an AGM or other Meeting of Members pursuant to the Act, those Directors or Members, as the case may be, may determine that the Meeting shall be held, in accordance with the Act and the Regulations, wholly or partially by means of a telephonic, electronic or other communication method. Thus Members present for the meeting may be joined electronically by Members not actually present, or alternatively, the meeting may be held with all Members connected electronically. However, Members participating electronically must be able to clearly hear and to be heard by all those attending the meeting. In addition, there must be a means to collect, count and include their votes on Motions as if they were present at the meeting. In accordance with Subsection 159. (4) of the Act, Members participating in a meeting electronically in this manner are deemed to have been present at the meeting.
- 2. A meeting by electronic means will be conducted through a conference call using telephones, speakerphones, computers running a web conferencing program, or other suitable electronic devices. Individual Members may be allowed to dial in, but Branches will be encouraged to gather as many Members as possible in a suitable room or rooms, each with a communication device. A controller, who will coordinate and control the communications in a manner very similar to a "directed net", will assist the Chair. Special instructions will be issued for each meeting conducted in this manner.

- 3. Normal voting may be conducted by show of hands of those present at the meeting, and/or by voice roll call for those using electronic communication. However, it will not be possible to carry out a vote by ballot should this be requested by a Member in accordance with Subsection 165(1) of the Act. Should this situation arise, the Chair will suspend the Motion until such time as arrangements can be made to conduct the vote on the Motion by means of mail-in ballots and electronic voting, using the methods described in paragraphs 2.04 and 2.05.

- 6. In paragraph 5.05 Committees, sub-paragraph 2, lines 3 to 5, delete the sentence: "Subject to continuing concurrence of the Board, the Standing Committees will be: Governance; Finance; Membership; and, Public Policy and Communications".
- 7. In paragraph 6.02 Notice of Meeting, line 2, delete "seven days" and insert "five full days". Insert "AL2" at the end of the last line of the paragraph.
- 8. Delete paragraph 6.04 Meeting Held Entirely by electronic Means, and insert new paragraph 6.04 Meeting Held Wholly or Partially by Electronic Means;

### "6.04 Meeting Held Wholly or Partially by Electronic Means AL2

- 1. The Chair of the Board, or Directors, may call a meeting of Directors pursuant to the Act. In accordance with Subsection 126. (3) of the Act, no person shall act for an absent Director at such a meeting. The Chair or the Directors, as the case may be, may determine that the Meeting shall be held, in accordance with the Act and the Regulations, wholly or partially by means of a telephonic, electronic or other communication method. Thus Directors present for the meeting may be joined electronically by other Directors not actually present, or alternatively, the meeting may be held with all Directors connected electronically. However, Directors participating electronically must be able to clearly hear and to be heard by all those attending the meeting. In addition, there must be a means to collect, count and include their votes on Motions as if they were present at the meeting. In accordance with Subsection 136. (7) of the Act, Directors participating in a meeting electronically in this manner are deemed to have been present at the meeting.

- 2. The meeting using electronic facilities will be conducted by means of a conference call using telephones, speakerphones, computers running a web conferencing program, or other suitable electronic devices. Instructions will be issued for each meeting conducted in this manner. AL2
- 3. Normal voting may be conducted by show of hands of those present at the meeting, and/or by voice roll call for those using electronic communication. However, it will not be possible to carry out a vote by ballot should this be requested by a Director in accordance with Subsection 165. (1) of the Act. Should this situation arise, the Chair will suspend the Motion until such time as arrangements can be made to conduct the vote on the Motion by means of mail-in ballots and electronic voting, using the methods described in paragraphs 2.04 and 2.05.

- 9. Delete paragraph 7.05 Relationship to HGMF, and insert new paragraph 7.05 with same title:

"The Officers listed in paragraph 7.01. 1 above are Members of the Board of Trustees of HGMF. In addition, the Past President and the Chair of the Finance Committee are Advisors to the Board. See also paragraph 2.03. 2 of these By-laws, concerning the relationship between the HGMF and the Council.

10. On the By-law No. 1 Record of Approval and Amendment, the last pages of the By-law, after paragraph 2. Amendment One, insert a new paragraph 3. Amendment Two;

"3. Amendment Two AL2

a. The second amendment to By-law No.1 was tabled for consideration and approved by the PPCLI Association Board of Directors at their teleconference meeting held on 11 April 2018. The amendment will be presented to Members for confirmation at the AGM to be held at Medicine Hat on 26 May 2018. The amendment is effective on 11 April 2018, the date it was approved by the Board. A copy of the newly-amended By-law No.1 including Amendments One and Two, will be forwarded to Industry Canada/ Corporations Canada, together with a copy of the certified AGM Resolution 01-18, both for their retention.

- an updated definition of e-member (paragraph 1.02. k);
- an updated definition of "spousal or partner member" (paragraph 1.02. s);

- a replacement paragraph reflecting changes to the structure membership dues as a result of the cancellation of the practice of automatically mailing hard-copies of the *Patrician* to Association Members (3.01. 1);
- a replacement paragraph introducing suspension of membership for non-payment of dues after three months, and termination of membership if dues have not been not paid by the end of the calendar year (3.01. 2);
- a revision to the procedures for conducting meetings of Members either wholly or partially by electronic means (4.09. 1, 2, and 3);
- deletion of the list of Standing Committees (5.05. 2);
- a change to the notification time required in advance of meetings of the Board from seven to five days (6.02);
- a revision to the procedures governing meetings other than Meetings of Members, primarily Board Meetings, held wholly or partially by electronic means (6.04. 1, 2 and 3); and,
- a revision to the list of Members of the Board of Trustees of HGMF, and the addition of Advisors to the Board (7.05).

### Reflections on Medak 25 Years On; Operational Success and Operational Stress By Bryan Bailey, former OC C Coy at Medak



This year marks the 25<sup>th</sup> anniversary of the Medak operation and I was pleased that the President of the Regimental Association asked me to write a short article about its significance. Like many, I am extremely proud of the Second Battalion's accomplishments during its 1993 tour in Croatia and I would like to share a few opinions and thoughts. I will also reflect on the exceptionally heavy toll that Medak took in terms of operational stress injuries because, sadly, the operation that took place in September 1993 was the catalyst for many operational stress injuries, some of which only manifested many years later.

The Medak operation was indeed unique for a number of reasons. First of all, it was a multi-national Battalion level operation; two French mechanized infantry companies were attached to the battalion along with a small contingent of unarmed Military Observers from other countries. Secondly, it dramatically underscored the reality of post-Cold war peacekeeping as the UN was deployed into a number of ongoing civil wars which are inherently more complex and dangerous than traditional peacekeeping. Medak has become synonymous with a dramatic evolution in peacekeeping and the imperative to be more robust and expeditionary. Thirdly, the Medak operation constituted a relatively rare example of a successful Battalion level UN peacekeeping operation which helped restore some of UNPROFOR's beleaguered and battered credibility in Sector South. Lastly, the subsequent conduct of the UN special assessment into ethnic cleansing led to the International Criminal Court indictment of a Croat General.

In addition, 2 PPCLI garnered significant praise for the manner in which it was very rapidly force generated and successfully integrated an exceptionally high number of Reserve soldiers. Hundreds of reservists answered the call to arms from coast to coast on essentially no notice. While the 44% reserve augmentation number is astonishingly high, a better measure is that two thirds of the soldiers deployed at the sharp end were drawn from the ranks of the Army Reserve and most were less than twenty years of age. It was these same soldiers who were exposed to the highest risk and grisly aftermath of ethnic cleansing.

Our Reserve soldiers were returned to their parent units only a few days after our redeployment to Canada. While the Regular Force was becoming better at recognizing and treating operational stress injuries, our Reserve brethren did not enjoy the same access to care. To make matters worse, they did not have the same level of peer support which might have mitigated some of their stress injuries. The Reserve chain of command correctly observed that many of their soldiers were suffering from invisible injuries upon return. In response, 2 PPCLI was tasked to dispatch teams of leadership who served at Medak. While well intentioned, these teams were not able to reconnect with those who were experiencing the greatest post-tour transition and operational stress difficulties.

Many in the unit will recall that Psychiatrist Greg Passey, then a serving military Medical Officer, fortuitously selected 2 PPCLI for a study on operational stress. Every member in the unit was surveyed both pre-tour and post tour in a very comprehensive manner. I recall that the results seemed improbably high to me at the time, as they indicated that we had become the most stressed unit in the Canadian Army with one in nine having suffered a significant stress injury and two thirds stressed at lower levels. We all accept that stress comes with the territory when deployed on operations and, fortunately, not all stress exposure manifests into injury. That said, an inordinately large number of stress injuries were a result of that tour. One of the aspects of PTSD that was not generally understood until more recently was the cumulative nature of stress. Over the years I became aware of many more veterans of the Medak operation who suffered from operational stress injuries. Sadly, many of the very best soldiers and leaders were medically released, much to their reluctance. Not surprisingly, many of the leaders who carried the day as the "go to guys" bore the brunt of the stress and succumbed to the insidious effects of stress. This very well might be related to their mission focus and overarching but conflicting desire to safeguard the welfare of their subordinates when confronted with lethal danger.

These same leaders also were part of the system designed to help other soldiers deal with stress. The battalion certainly did not enter the theatre totally unprepared for stress. The two unit Padres, Mike Brown and Bob Sparks, both of whom were exceptional and now sadly are deceased, conceived and delivered a leading edge peer support counselling programme with the aim of mitigating the effects of stress exposure. Every company was mandated to have at least one trained peer support counsellor in each section. I was initially uncertain about this approach, so in Charlie Company the peer debriefer was either the Section Commander or 2IC as I felt that these positions would benefit the most from the education and training and

would be better able to identify stress affected individuals. Furthermore, I believed that they would have the credibility to effectively lead the debrief sessions and defuse stress. While not a panacea, every tool was beneficial. However, supporting others is also stressful.

Many members of the battalion will recall that a team of military mental health specialists was deployed into theatre with a mandate to conduct stress debriefings immediately prior to our redeployment. While recognition of the need and the rapid response by NDHQ was admirable, the execution and effectiveness was deemed to be largely ineffective as they lacked sufficient credibility to interact with the soldiers.

A final issue that led to disillusionment and stress for some members was the initial lack of appreciation for 2 PPCLI's accomplishments at Medak. Although the operation has become synonymous with steadiness under fire during an ugly era of largely unsuccessful peacekeeping missions, I recall that some of the sparse media attention was shockingly negative. This led to a great deal of disappointment and anger amongst those who were there. Fortunately, due to the efforts of several key leaders and, in particular, our unit CO, Jim Calvin, recognition would follow nearly a decade later. At an outstanding ceremony in 2002, then Governor General Adrienne Clarkson presented 2 PPCLI with her Commander-in-Chief's Unit Commendation.

The Medak operation is largely remembered for the firefights and steadfastness of the soldiers while under fire. To intervene between active belligerent forces, to stand our ground and respond with force to enforce a ceasefire agreement and compel the separation of Croat and Serb forces is a feat worthy of admiration. Given the threat of mines, direct and indirect fire, it is indeed miraculous that the unit did not suffer any loss of life. For the many who bore witness to this historical turning point in modern peacekeeping, and suffered invisible injuries, I hope that the significance of what the unit accomplished can be of some solace.

Fortunately, there are now much better resources available to those currently serving and veterans. While PTSD stigma is declining, far too many veterans still suffer in isolation with their invisible injuries. Worse, some veterans end up taking their own lives. For those who continue to suffer, you should be aware

of the PPCLI Association initiative to deliver Mental Health and Suicide Awareness Workshops. There have been two to date with more scheduled and the response has been excellent. In my opinion, there is nothing better than reuniting with members of the Regimental family. Taking part in a Regimental workshop may be the easiest first step to managing stress injuries.

I would also like to make mention of the Wounded Warriors fundraising bike ride which will be held in the Balkans this year. The ride will start in Sarajevo on June 9<sup>th</sup> and end in Medak on June 15<sup>th</sup>. Paul Hale, Martin Kenneally and Mike Spellen are a few members of the Regiment who come to mind as participants. The challenging route will cover more than 560 kilometres over the week. Paul Hale's goal is to raise \$10,000 in order to cover the cost of training a psychiatric service dog for a veteran, which is an admirable goal.

The Legion has prepared a very attractive commemorative pin which might be of interest to many who participated in the Medak Operation. Here are the images of the pin and text. It is hoped that there will be a good turnout of those who participated in the operation, although it will be impossible to equal in number the Medak old guard that marched into the old Winnipeg Arena as part of the 2002 ceremony.

It is hard to believe that 25 years have come and gone. Most of us who served at Medak have either retired from military service or are nearing retirement. If you haven't already done so, do yourself a favour and join the Association. Our Regiment is the most inclusive organization on the planet, "Once a Patricia, Always a Patricia!"

### LCol Alfred Glynn Pearson, MC, DCM

Alfred Glynn Pearson was born in Staffordshire, England on 16 August 1880 and as a young man emigrated to Canada. His civilian occupation was a shipping agent and he served for 3 months with the 34<sup>th</sup> Fort Garry Horse, Winnipeg in 1914. On 24 December 1914, he volunteered and enlisted as a Private (51383) for overseas duty in the 1st Reinforcing Draft, PPCLI, also known as the 500 Draft. They embarked in Halifax and arrived in England onboard the SS Southland on 29 January 1915. The draft was temporarily barracked at Tidsworth, Wiltshire England. Promoted to Lance Corporal, Pearson crossed to France on 23 February 1915 and was taken on strength with the Regiment in the field at St Eloi, Belgium on 1 March 1915.

Lance Corporal Pearson fought at Battle of Frezenberg 8 May 1915 and was noted along with three other NCOs for their brilliant handling of the withdrawal where the officers had fallen<sup>1</sup>. He was wounded during that action with shrapnel wounds to the neck and back. He was evacuated to Rawal Pindi British Hospital at Wimereux, France on 10 May. Pearson was then transferred by hospital ship to England where he was treated for his injuries and discharged on sick leave until 11 July. He was promoted to Corporal and returned to France on 23 August. He rejoined the Regiment at Armentieres on 1 September 1915.

He was awarded the Distinguished Conduct Medal for actions at the Battle of Frezenberg. His citation reads: "For conspicuous gallantry and devotion. After practically all the garrison at the front trench had been killed or wounded by the enemy's shell fire, Lance Corporal Pearson, with a few men, still held on, and, fortunately, although wounded himself, managed to bring out the survivors in safety after a new position had been taken up." Lance Corporal Pearson is the soldier carrying the ammunition box in the Frezenberg painting below by W.B. Wollen

Pearson was promoted in the field to Temporary Lieutenant on 20 December 1915 and was appointed Bombing Officer. During the Battle of Mont Sorrel (Sanctuary Wood) he was wounded in action on 2 June 1916. It was not until after the battle that he learned his organization and training of the bombers had contributed towards the success of the defence.<sup>3</sup> Due to the shrapnel wounds to the right forearm he was evacuated to England for treatment. He was discharged, declared fit for duty and attached to RCR/PPCLI Depot at Shorncliffe on 7 September 1916. He rejoined the Regiment in the field at the Somme on 10 October 1916.

On 19 December 1916, the 172<sup>nd</sup> Tunneling Company blew three underground mines in front of the PPLCI lines. Lieutenant Pearson was in command of two 30-man groups of Patricias who were tasked to seize the newly created craters. Lanes had been precut in the wire and duckboards had been laid in preparation for the operation. The near lips of the craters were successfully seized at a cost of nine casualties. At the request of Lieutenant-Colonel Agar Adamson, the main crater was given the official name of "Patricia". The crater was some 250 feet in diameter and 60 feet deep, and it can still be seen today when you visit Vimy Ridge.

Pearson was promoted to Temporary Captain on 9 January 1917. He was subsequently made Acting Major and took command of #3 Company on 16 February 1917. Major Pearson commanded #3 Company which was left forward during the Battle for Vimy Ridge on 9 April 1917. The company took 68 casualties with at least 13 killed in action.<sup>5</sup> Major Pearson was wounded during the assault with a gunshot wound to the chest and left lung. It should be noted that Pearson reverted to the rank of Captain when he relinquished



command of #3 Company after being wounded. He was evacuated to England for a third time on 20 April 1917 and was discharged from the hospital on 7 July 1917. He was then posted to the Eastern Ontario Regiment Depot and 6<sup>th</sup> and 7th Reserve Battalions while awaiting a Medical Board. Pearson was declared Medically Unfit for duty and appealed directly to Lieutenant-Colonel Gault for a position in France.<sup>6</sup> He returned to France as Adjutant 3rd Canadian Division Wing, Canadian Corps Reinforcing Camp on 25 April 1918.

Pearson was seconded back to the Regiment after the terrible losses during the Battle of Tilloy, just outside of Cambrai. He was promoted to Acting Lieutenant-Colonel on 15 October 1918 replacing Lieutenant-Colonel Stewart who had been killed in action on 28 September 1918. He led the Regiment to Mons and the Armistice. Pearson retained command until 21 November 1918 when he relinquished the post to Lieutenant-Colonel Gault. He reverted to Temporary Major on 22 November 1918. However, he was Acting CO, during Lieutenant-Colonel Gault's absence on leave.

Major Pearson returned to Canada with the Regiment on the SS Carmenia, arriving in Halifax on 17 March 1919. He travelled with the Regiment to Ottawa and most likely participated in the 19 March arrival parade where the Regiment was reviewed by the Governor General. He was demobilized from the CEF on 20 March 1919. He was awarded the Military Cross on the occasion of His Majesty's Birthday. There is no citation for the award, but it is believed to be in recognition of his leadership of the Regiment in the last days of the war.

On 1 October 1957, Lieutenant-Colonel AG Pearson, MC, DCM participated in the official breaking of ground for the Frezenberg Memorial. Our founder, Brigadier General Hamilton Gault, DSO, ED, CD turned the sod and planted a maple tree in the centre memorial. In addition, the service was attended by two other Frezenberg veterans, Lieutenant-Colonel HW Niven, DSO, MC who was a subaltern and Sgt HF O'Connell who lost an arm at the Battle.<sup>7</sup>



Lieutenant-Colonel Alfred Glynn Pearson, MC, DCM died on 11 December 1967 in Orpington, Kent, England at the age 87.

# 100th Anniversary of Passchendaele

10 November 2017 marks one hundred years since the end of the horrific battle of Passchendaele. Also known as the Third Battle of Ypres.


The Canadian Government sent a delegation to Belgium to take part in ceremonies to commemorate the 100<sup>th</sup> anniversary of Passchendaele. I had the great privilege to be chosen by the Association to represent the Princess Patricia's Canadian Light Infantry for this occasion. The delegation consisted of Members of Parliament, the Royal Canadian Legion, Army, Navy, and Air Force Veterans of Canada, one Senator, the 2017 Silver Cross mother, First Nation members, youths from across Canada and 10 Veterans each representing a Regiment that had a Victoria Cross recipient from the Battle of Passchendaele in the Autumn of 1917.

The delegates arrived in Ottawa in the afternoon of 5 November 2018. The next day we spent touring the National War Museum. In the evening we attended the annual Candlelight Tribute to the fallen. Due to a flight delay we toured Parliament Hill and the National War Memorial.

On the 7<sup>th</sup>, we flew to Lille France our base for the trip. Arriving at 06:00 hrs we quickly stored our kit in our rooms and took off for a Battlefield tour. At Passchendaele we meet our historians and walked part of the ridge. The historians explained and pointed out the start lines and objectives of each Battalion.

The Battle of Passchendaele was initially launched on 31 July 1917 by the British. In September 1917, Field Marshall Haig, Commander of the British Expeditionary Force ordered in the Australian and New Zealand troops (ANZAC). By October these troops were severely depleted and worn out. Field Marshall Haig, then ordered the Canadian Corps an assault force of 100,000 storm troops to take the ridge. General Currie, commander of the Canadian Corps, opposed the plan predicting it would cost 16,000 Canadian casualties. His estimate was only short by about 500 men. Currie's strategy was to take the ridge in short limited objectives. A bit and hold attack then bring in fresh Battalions for the next objective. On 26 October 1917, the 4<sup>th</sup> Canadian Division launched the first attack, led by the 46<sup>th</sup> (South Saskatchewan) Battalion. This was my grandfather's Battalion. On 30 October, the PPCLI were the right forward Battalion as part of the 3<sup>rd</sup> Canadian Division and they attacked up the north spur towards Duck Lodge and Meetcheele. On that morning the Patricia's stepped off 600 strong by the end of the fight there would be 237 left standing and two Victoria Cross's.

The night before the attack, Sgt George Mullin was doling out the rum ration to his troops and was heard to say, "I'm feed up to the teeth. Tomorrow morning it's either a wooden cross or a VC for me". Sgt George Mullin and Lt. Hugh McKenzie were both awarded the Victoria Cross along with seven other Canadians in the battle of Passchendaele.



Walking the ridge and seeing first hand where the Patricia's fought in October and November 1917 gave me chills. Looking across at the area where Mullin and McKenzie took out the Pill box's. In that period, the landscape would have been a lake of slim and mud, shell holes filled with water, covered by enemy fire, artillery and it seemed an impossible task to advance.

I also walked part of the route taken by my grandfather's Battalion on 26 October 1917 and was amazed to find a shrapnel ball from the field. It will find a home in the case with his Medals. My grandfather, Corporal Gestur E Hjalmarson, joined the Canadian Army in 1915 serving with the 46th Battalion (South Saskatchewan). He arrived in France on 10 August 1916 and fought in most of the major battles of the war, including Passchendaele. He was wounded twice and was awarded the Military Medal twice. Gestur survived the war and in June 1941 he joined the Veterans Guards of Canada. He died on duty on 22 January 1942 and is commemorated on page 82 of the Book of Remembrance in the Peace tower on Parliament Hill.

On the evening of 8 November, we were at the Menin Gate in Ypres to take part in the Last Post Ceremony that is done every night to commemorate the fallen with no known resting place. The Canadian contingent took a large part that night with First Nations dancers and the Canadian guard unit. I had the greatest honour to recite the Act of Remembrance in the hallowed place. To know that my voice was the only thing heard at that moment echoing off the stone walls of that magnificent Memorial Gate will stay with me forever.

The following morning, we headed to the St Julien Canadian Memorial to dedicate a new plaque to commemorate the almost impossible accomplishment of the Canadian Corps in taking Passchendaele Ridge. The next stop for the day was at the Passchendaele Memorial Gardens. Here countries that took part in the Battle of Passchendaele each have their own garden with plants native to their country. We had a small ceremony to open the New Canadian garden. After the Ceremony we toured through the Passchendaele Memorial Museum. They have reconstructed trenches and underground bunkers. The rooms are set up just as they would have been in 1917 and full of artifacts.

The afternoon found us back at the Passchendaele Memorial to dedicate the Canadian Gate. This is the sister gate to the one in Halifax Harbour called The Last Steps. It honours the 350,000 Canadian soldiers who boarded ships at pier 2 to go to WWI. It has footprints going through it to the harbour. At Passchendaele the footprints emerge from the Gate and into the village of Passchendaele. A very moving Monument indeed. That evening we watched the Sunset Ceremony at the Passchendaele Monument. Music was provided by Royal 22<sup>nd</sup> Regiment band. Soldiers from Regiments across Canada provided the guard which was commanded by a Patricia Major from 1 PPCLI.

The 10<sup>th</sup>, found us at Tyne Cot Cemetery for a very moving Commemorative Ceremony with all dignitaries and Parliamentarians including the Minister of National Defence. Letters from a WWI German Officer and a Canadian Signaler were read. After the end of the ceremony the Minister of Defence handed out a few challenge coins to members of the delegation. We then had some time to wander the cemetery looking for fallen members of our respective regiments.

We then headed to Essex Farm Cemetery to conduct a short Commemorative Ceremony to Lt.Col. John McCrae. The field hospital where he worked and the Cemetery he wrote In Flanders Fields has been restored. Tourist can walk into the small rooms of the hospital and try to imagine the horrors that were seen in them.

That night we took part in a torchlight parade from the Passchendaele Memorial to the Village market square and local church.


On November 11<sup>th</sup> we assembled at the Novotel Hotel then made our way to the St. Martin Cathedral to take up our place in the parade to the Menin Gate. The bugles played Last Post and as the wreaths were laid and the music played Poppy petals fell through the openings in the roof. Gently floating down on the people gathered in this hallowed place to remember the tragic loss of life in that terrible war.

After a relaxing lunch we went to Hill 62 (Sanctuary Wood) another hard battle for the Regiment. We held a short Remembrance Ceremony then spent some time to place Canadian flags and flowers on the resting places of Canadian soldiers. So sad to see so many fallen Patricia's in that place.

The following morning found us back in Ypres. This time to visit the In Flanders Field Museum. The curator gave us a great tour of this magnificent place. So many wonderful displays and articles to see.

After we grabbed some souvenirs and had lunch at the Meat House we made our way to the Passchendaele New British Cemetery to pay respects to Alex Decoteau. Alex was a Cree native who was the first indigenous person in Canada to become a police officer. In 1911 he joined the Edmonton Police Service. He also represented Canada in the 1912 Olympics in the 5,000 meter event. He enlisted in the Canadian Expeditionary Force in 1915 and died in the Battle of Passchendaele on 30th October 1917. That afternoon the youth of our delegation along with a couple of other members took part in the annual Alex Decoteau Poppy run in Zonnerad. Back at the hotel in Lille we held our farewell dinner to say goodbye to the wonderful staff that made our trip run so smoothly and the new friends we had all become. In the morning we boarded the plane that would take us on the long journey home.

It had been an outstanding trip and an honour to represent Canada and the Regiment on such an important anniversary. Friends were made, laughs and tears were shared. The Battlefields of the First World War where the Canadians fought is a must see for all Canadians but more so for anyone that has served this great country. To walk in the footprints of these great warriors on those fields, you still can feel their presence. May they all Rest in Peace.

# CHILLIWACK AND THE VIMY OAK LEGACY

After the Battle of Vimy Ridge in April 1917, a Canadian soldier name Leslie Miller wanted to take a souvenir home; something to remind him of what Canadian soldiers had so valiantly accomplished at Vimy. Leslie looked around and saw a half-buried oak tree. He picked up a handful of acorns and sent them home to be planted at his family farm in Ontario. Following Leslie's return to Canada his father gave him 24 acres of the farm. He named his land "Vimy Oaks Farm". Leslie replanted the young oak trees and ten of these trees are still standing today at Vimy Oaks Farm.

In 2017, the non-profit Vimy Oaks Legacy Corporation repatriated saplings from Vimy Oaks Farm to groups across Canada in commemoration of the 100<sup>th</sup> Anniversary of the Battle of Vimy Ridge and in remembrance of all Canadians who fought in World War One. The City of Chilliwack was selected to receive a commemorative sapling. On November 1<sup>st,</sup> 2017, a ceremony was held to mark the anniversary and plant the Vimy sapling. This was attended by Mayor Sharon Gaetz, several City Counsellors, 2 members of the Chilliwack RCMP Detachment and several former members of the Canadian Armed Forces, who had served at CFB Chilliwack along with a group of interested citizens. The oak sapling was planted in the Canadian Education Park, which is part of former Canadian Forces Base (CFB) Chilliwack. The Legacy Walking Trail was developed as a tribute to the men and women who lived and worked at CFB Chilliwack from 1942 to 1995 when the base closed. The Trail winds its way through Garrison Crossing and the Canadian Educational Park to its end at the Vedder River Rotary Trail. Visitors and residents can walk along the pathways and learn about the history of CFB Chilliwack and the vital role it played in Canada's military. # The plaque mounted on the stone in front of the oak reads:

"Vimy Ridge rises above the Doual Plain, France. The ridge is tactical, strategic, formidable and desired. On a harsh Easter Monday, April 9, 1917 soldiers of Canada's four infantry divisions, brought together for the first time as a single fighting force, captured this landscape. Hailed as a nation born, Canada's soldiers from east to west, urban to rural became equal one to the other. Among them soldiers from Chilliwack who shared with their brethren each step to assail the ridge and every step into eternity.



This Oak tree (Quercus robur) is a descendant of an Oak tree that once stood at the site of the Vimy Ridge Battle in France. Lt. Leslie Miller a Canadian soldier realized that Canada had accomplished something great and looked around for a souvenir. He collected a hand full of acorns from a half buried Oak tree and sent them home to be planted in Ontario at his family farm which he called "Vimy Oaks Farm". They grew into majestic oaks that still stand today."


