
7.3 HGMF Fundraising



- 1. Casinos are conducted approximately every 18 months with the funds becoming available approximately six months later. These funds are considered "Deferred Revenue" until they are programed in the budget on a monthly basis of Casino Revenue/18 months x 12 month.
- 2. Donations of \$5,000 to HGMF for Bursaries from Casino Account.
- 3. Cadet Support is related to purchase of Hatbadges and flashes and financial support to the three PPCLI cadets corps in Alberta.
- 4. Veterans and Family support are donations to Col Bechner, Kipness Center and Veterans Association Food Bank in Calgary and Edmonton.

8.3 Association Financial Review

Background

Given the split of the HGMF from the PPCLI Association. The Association finances are reduced to the General Operating Account and the Casino Funds

The need for a formal review of the Annual Budget is significantly reduced and it is believed that an independent review by a financial advisor will be sufficient.

8.5 Special Resolution 01-21

A Special Resolution clarifying the relationship between the PPCLI Association and the Hamilton Gault Memorial Fund

BE IT RESOLVED BY SPECIAL RESOLUTION THAT:

PPCLI Association By-law Number One be renamed PPCLI Association By-law Number Two, and be further amended as follows:

- 1. <u>Article 2.03 Council of Presidents.</u> Delete paragraph 2: "In addition, the Council is responsible for oversight of the Hamilton Gault Memorial Fund (HGMF). The Board of Trustees of the HGMF is responsible to the Council for all governance and policy matters affecting the Fund".
- 2. <u>Article 2.03 Council of Presidents</u>. Delete the paragraph numbering only for paragraph 1. (The detail remains unchanged.)
- 3. <u>Article 7.02 Relationship to the HGMF.</u> Delete the Article heading and all detail: "The Officers listed in paragraph 7.01.1 above are Members of the Board of Trustees of the HGMF, and the Past President and the Chair of the Finance Committee are Advisors. See also paragraph 2.03.2 of these Bylaws, concerning the relationship between the HGMF and the Council".

A Special Resolution to waive payment of dues in a special circumstance and to amend certain eligibility criteria for Supporting Membership

BE IT RESOLVED BY SPECIAL RESOLUTION THAT:

PPCLI Association By-law Number Two be renamed PPCLI Association By-law Number Three, and be further amended as follows:

- 1. <u>Article 2.01 Membership Conditions.</u> Delete the current para 2.b.(1).(b): "Parents of a person qualified to be a Member;" and insert a new para 2.b.(1).(b): "Parents; or, with the approval of the Board of Directors, up to two siblings or other close relatives of a person qualified to be a Member;"
- 2. <u>Article 3.01 Membership Dues.</u> Add a new end to the sentence in para 1.: "Annual dues may be waived for those Members who have prepaid for Life Memberships, for those previously admitted as Honorary Members, or for other Members or Supporting Members who are recommended by the Board for approval by Ordinary Resolution at a Meeting of Members. The Secretary, the Chair of the Membership Committee and Branch Presidents can each individually control and manage the initial membership and subsequent renewals of the gratis three-year memberships made available to eligible retiring CAF Members, and for the survivors of those who were eligible to be Members."
- 3. <u>Article 3.01 Membership Dues.</u> In paragraph 2, line 3, after "the Secretary," insert "the Chair of the Membership Committee,".

8.7 Special Resolution 03-21

A Special Resolution approving the suspension of the Vancouver Branch Charter; and amending the By-law in order to clarify the procedures for the approval, suspension, reinstatement, or revocation of Branch Charters

BE IT RESOLVED BY SPECIAL RESOLUTION THAT:

The Charter for the Vancouver Branch of the PPCLI Association be suspended with effect 17 October 2017; and that PPCLI Association By-law Number Three be renamed PPCLI Association By-law Number Four, and be further amended as follows:

1. Article 1.02 – Definitions.

- a. Add subparagraph t: "Suspension of a Branch Charter" means the Board has recognized that a Branch is no longer operating, and as a result has decided to suspend the Branch Charter.
- b. Add subparagraph u: "Reinstatement of a Branch Charter" means that the Board has approved the application of a group of Members to recommence operations as a Branch, and has rescinded the Suspension of the Branch Charter.
- c. Add subparagraph v: "Revocation of a Branch Charter" means that the Board has formally recognized that a Branch must permanently cease operations and, as a result, has decided to revoke the Branch Charter. This is an exceptional measure as there is no possibility for reinstatement.

Moved by Ted Giraldeau and seconded by Don Dalziel that the SR 03-21, a Special Resolution approving the suspension of the Vancouver Branch Charter; and amending the By-law in order to clarify the procedures for the approval, suspension, reinstatement, or revocation of Branch Charters be approved.

8.7 Special Resolution 03-21



2. Article 2.02 – Branches.

Amend Paragraph 1 as follows:

- a. Ten or more Members may apply to the Board of Directors to form or reinstate a Branch. Each application will be reviewed to ensure that conditions set by the Board are met.
 - (1) Upon the recommendation of the Board of Directors by Special Resolution, the formation of a Branch must be approved by Special Resolution at a Meeting of Members in order for a Branch to be granted a Charter.
 - (2) The reinstatement of a Branch Charter must be approved by a Resolution of the Board of Directors.

Renumber the next sub-paragraphs of paragraph 1: c. becomes b.; d. becomes c.; e. becomes d; f. becomes e;

8.7 Special Resolution 03-21



- e. A Branch may not suspend nor revoke its own Charter:
 - (1) As a result of either a Motion passed by the Branch which ceases its operation, or the Board determining a Branch is no longer operating, the Charter of a Branch will be suspended by approval of a Resolution by the Board of Directors.
 - (2) In exceptional cases where no reinstatement of a Branch will be allowed, revocation of the Branch Charter must be recommended by Special Resolution of the Board of Directors and submitted for approval by the passage of a Special Resolution at a Meeting of Members.
- f. In the event that a Branch Charter is suspended or is revoked, thus resulting in the Branch being dissolved, the distribution of Branch funds and property will be decided by the Members of the Branch.
- Paragraph 3: A Special Resolution of the Members is required to make any amendment to the By-laws of the Association to change the manner of approval of an application to form a Branch, or to revoke the Charter of a Branch.
