

# MESSAGE FROM THE COLONEL OF THE REGIMENT

As this is being written Second Battalion has just completed its rotation to Winnipeg from Croatia. The unit had a most successful tour, having been redeployed from its initial tasks in the Daravar region to an entirely new tasking in Krajinia near Gracic. They were selected to monitor an area formerly supervised by French peacekeepers, accomplished the move very effectively and put a grip on activity in the area.

Lady Patricia and I visited the new location of Second Battalion from 11 to 14 September. Just prior to our arrival in the area, shelling in some company locations accompanied moves by both Croat and Serb forces trying to establish control in areas which had changed hands. The unit managed to establish the first land corridor from Serb to Croat positions and was in the process of interposing our Peacekeepers between the two sides as agreed in a new cease-fire.

The area visited was large--about 2000 square kilometers and posed real challenges in security, control and communications. The unit was composed of just over 40% Militia who were fitted in well and did an excellent job with the Battalion. Morale of all was high and a great deal of satisfaction was evident in meeting all the challenges thrown at them. As with their sister Battalion, the Third, Second Battalion was highly regarded by the Commander UNPROFOR and not only maintained but enhanced the reputation of the Regiment.



# PRESIDENT'S MESSAGE

This year marked the Fortieth Anniversary of the Incorporation of the Association. How did we let it slip by unnoticed?

When the Association was Incorporated on September 1st, 1953, our World War I vets were in their 50s and the Second War guys in their 30s. The Korean War had just ended and our Third Battalion was preparing to come home. Forty years later, the Third and Second Battalions have recently completed tours on UN protective duties in Croatia and the First Battalion is preparing for its tour in early 1994. Our Korea vets are now in their 60s and we have a whole new generation of soldiers serving in our Regular battalions.

The 45th Annual General Meeting at Vernon Camp on the 5th of June was the largest gathering of Association members and friends since the 75th Anniversary Reunion. There was standing room only at the General Meeting, and over 150 people attended the Association Dinner. The weather was beautiful, the facilities excellent, and members of the Okangan/Thompson Branch, with terrific support from CFB Chilliwack and the staff at Vernon Camp, worked very hard to make this a memorable event.

I thank you all for your show of faith in electing me to a second term as National President. Some of my objectives were not met during my first term, but with this additional time you have given me, the assistance of our dedicated Executive and your continued support, I am confident I will not let you down.

The Regimental Heritage Committee has pretty well smoothed out its organizational bumps, confirmed its terms of reference and drafted a constitution. Most Association branches have appointed Branch Heritage Coordinators to work with this committee, and we should soon be seeing some projects underway.

Vice President (West) Lloyd Jones and Vice President (East) Bill Love are commencing a campaign to recruit Militia soldiers who served with our Battalions in Croatia into the Association. The plan is to obtain names and addresses of these soldiers from the Regiment and pass them on to appropriate Branches. Branches will then be expected to contact the individuals, befriend them and invite them to join the Association. If this plan is to succeed, we must contact these people immediately, while they still identify with the Regiment.

Plans are well underway for the Regiment's 80th Anniversary Reunion in Calgary, July 1st to 3rd, 1994. As most of 1st Brigade will be in Yugoslavia by that time, we will not have the number of troops on parade that we had at the 75th, but we will still have a great reunion. Some features of this event will be the ribbon-cutting at the Bunker in the Regimental Museum, the 46th Annual General Meeting of the Association and the Change of Command of the Colonel of the Regiment, when Major-General Herb Pitts will turn over to his successor. The Colonel-in-Chief will preside over the Change of Command and I would like to see a strong Old Guard on parade.

See you in Calgary July 1st.

#### MUSEUM UPDATE

- 1. The preservation of our Regiments History as told in the PPCLI Museum has been made possible by you; the PPCLI Association; the serving soldier and our corporate sponsors. Many think of only the monitory cost of the Museum. The actual cost is much more than this; it is the artifacts and pictures donated; the volunteers who give their valuable time as staff at the museum; and yes the kind dollars you donate large and small that are aiding in the completion of our Museum. To everyone Thank You for your kind support.
- Your museum is nearing completion with the latest addition to be completed by 11 November 1993. This area is Phase 3 and includes the following:
  - a. The Founding of the Regiment;
  - b. Heading Overseas;
  - c. The Bunker (WW I) final completion date 1 Jul 94; and
  - d. The Airborne display.
- 3. Our final phase of construction will commence 15 November 1993 and be completed hopefully by the years end. The financing for this final phase is still being secured and may delay the start up date; as we will not go into debt to complete the Museum.
- 4. Your continued contributions to the Bunker Fund and Building Blocks will help to ensure the completion of this final phase.
- 5. During the AGM in Vernon a young lady brought up the subject of the iron gate entrance to "Hamilton Gault Barracks" which was donated by the PPCLI Wives Club. The gate has been removed but will be placed in the Museum over the Barracks Room display with a suitable plaque recognizing the PPCLI Wives Club and their kind donation. In Edmonton, Alberta at Hamilton Gault Barracks there is a cairn recognizing the position of the gate and the kind donation of the Ladies.
- 6. I hope this short note has brought you up to date on all the hard work that Keith and the staff at RHQ have been doing to ensure the success of your Museum. I look forward to seeing all of you at the 80th Anniversary in Calgary; 1 3 July 1994.

Our Newsletter does not usually carry book reviews, but "Tapestry of War" describes the founding of our Regiment and helps to make the names of our "Originals" come to life with flesh and bones to their names. I feel that the book would be of interest to all our members, hence the brief book review, which is below:

The study of Regimental history helps to install "Esprit de Corps" and to give members the feeling of belonging to a family, a regimental family. All too often, though, the story of the Regiment lacks the human feeling of what it was like in those bygone days.

"Tapestry of War" A private view of Canadians in the Great War, by Sandra Gwyn does just that. The early members of PPCLI come to life with all their successes, failures, loves and ambitions. The book is published by Harper-Collins Ltd.


The book introduces the reader to the social life of Ottawa and describes the life of the young people who are about to endure the Great War. Of particular interest to Patricias is the description of the founding of our regiment and the appointment of the first officers. One of the best officers Agar Adamson, (old Ackety Ack) was a forty eight year old Captain, was portly and had poor eyesight....he would be rejected in todays army! Other officers are mentioned in some detail, such as Talbot Papineau and the amazing letters he wrote to a young woman in the USA whom he never met. Fortunately the letters still exist and describe in detail the life in the trenches.

Chapters of "Tapestry of War" describe the impressions of Adamson and Talbot about life in the trenches, the death of Lt Col Farquar, the PPCLI in billets at Ypres, Papineau rescuing the Regimental colours, as well as the PPCLI on the Somme and at Passchendale. The change of the hat badge from a Margarite is described in more detail than in our Regimental history. The book concludes with Adamson and Hamilton Gault bringing Princess Patricia's Canadian Light Infantry home to Canada. There are numerous photographs of our Princess and of our Regimental officers and men.

I believe members of our Association would be interested in this book.

Also a headtable guest was John Loy, our only World War I member, who again entertained the assembly with a war story! The sequel unfolds as follows; "The year was 1917 and somewhere in Flanders fields in a muddy trench John was making preparations for his evening meal (Aussie Bully Beef). This evil tasting grub, unpalatable when cold, improves somewhat when warmed up, so John had gathered the means to accomplish this task. But alas, just about when the beef got warm, a little smoke wafted over the parapet and alerted a Hun sniper. His well aimed shot holed a sandbag above his cooking stand, and a trickle of sand sprinkled into the Bully Beef. As John relates, as far as he was concerned the war was not personified, but that treacherous act by the Hun sniper was the last straw, henceforth this war became personal".

A fortnight later John celebrated his 99th birthday at home and I was honoured to personally hand him congratulatory messages from the Colonel-in-Chief, the Colonel of the Regiment and the National President.

On August 15 a very successful BBQ and Games was held at the 3 PPCLI WO's and SGT's Mess. In conjunction with the local branch of the KVA, we tested our mettle on the sportsfield. Gold medal in the horseshoe event went to Bruce and Lois Dickey, the 'Bocce' game was won by Joan Chevrier and her friend Carroll.

We proudly watched the Welcome Home Parade on April 9 in front of the British Columbia Legislative Buildings. Following the parade there was an informal reception at Work Point Barracks where we had a chance to talk with the returning soldiers. Well done 3 PPCLI!

On July 3, Canada Day celebrations were observed with 3 PPCLI receiving the Freedom of the City of Victoria and the Freedom of the Municipality of Esquimalt in successive parades. Both the Colonel-in-Chief and the Colonel of the Regiment were in attendance and some of our members had a chance to chat with them after the parades.

Many of our members attended the very impressive Sunset Ceremony which was conducted on the Legislative Grounds the next day, with the main participants again, the Third Battalion.

With deepest sympathy to the family of Cpl John Bechard, killed in Croatia Aug 6, 1993, Ed Rawluk and Del Reaume represented the PPCLI Association at the funeral near Windsor, Ont.

SB153925 Allen Thomas died on April 6, 1993 in Hamilton, Ont. Allen served in Korea. He was an avid supporter of our Branch since its beginning.

We will remember them.

A donation from our Branch was sent to the Trust Fund for Baby Bechard.



# TORONTO BRANCH



I had written to the editor of the Beaver magazine in Winnipeg, Christopher Dafoe, asking if he was related to Van Dafoe (H16403). A return letter from him on August 14th informed me that the one I knew was one and the same the son of John Dafoe of the Winnipeg Free Press. "One of my earliest memories is of watching the PPCLI marching off to war in 1939 and I was at the Union Station in 1944 to watch a large group of Patricia's return." "My uncle settled in British Columbia after the war and died in the 1960's in Kitimat, he had one daughter, Brenda Dafoe, who still lives in B.C."

The last time I met up with Van Dafoe was at a place called Guardiareia, nine miles south of Campobasso, in southern Italy. Van used to chum around with a chap named Bill Cameron (P20619).

I was given one of the back issues of the Patricia, 1967 and in reading through it I found some very interesting articles. One item that I had often wondered about was one on William Marsden, he was a former member of our assoc'n. "The Grand Old Man of the Regiment, RSM Bill Marsden, died at the home of his son in a Toronto suburb on August 28th, 1967. He was in his 96th year. Captain Marsden served in South Africa with the King's Shropshire Light Infantry, and won the DCM during the Paardeberg campaign in 1901. When the Patricia's were formed in 1914 he was appointed RSM and was given Regimental No 1." Pat Marsden, the sportscaster is a grandson.

John Slimkowich (H16937) passed away on July 29th at Providence Centre, Scarborough, Ontario. A Memorial Mass was held at the Chapel of the Centre on Saturday, August 7th, a reception was also held at the Centre where the members of the Assoc'n attending met the family and relatives. A wreath and card was placed in front of the Alter on behalf of the Toronto Branch, John Clarke made these arrangements. The Colonel of the Regiment, Major-General H.C. Pitts and Mrs. Pitts, Mr & Mrs Clarke, Ches Helgason, Dave Middleton and myself attended.

John was a very colourful person, I first met him at Fort Osborne Barracks in Winnipeg where we had enlisted together. At that time he told me he came from Sudbury, Ontario, where he had worked at the mines and that he had served in the Mackenzie/Papineau Bridge in the Spanish War just before 1939. When the Patricia's were in Sicily and Italy John was with the Scouts and Snipers. In "Once a Patricia", Colonel Syd Frost, the author, allots quite allot of space telling about the exploits of John. When the Korean War started, away he went again, although I am sure he did not have to go, but he was like that, good hearted and very conscientious, his family loved him. #### IN MEMORIAM



October 1952 . . . A Korean Hill called Carson's Outpost, occupied by 1 PPCLI, a young Saskatchewan lad was struck down by a Chinese mortar.

Robbie Robertson, himself the son of a WWI Patricia, was about 19 at the time. He was evacuated to the MASH unit, from there to Tokyo and then back to the Military Hospital in Winnipeg. Here he started the long journey, recovering from his wounds, dealing with the loss of mobility, and spending the next 40 years in a wheel chair.

While at Winnipeg, he fell in love with a young nurse from Nova Scotia who was doing great deeds, as nurses do, with the wounded from the War in Korea. Eventually they married and moved to Brooklyn, Nova Scotia, where they raised a son and daughter.

Robbie and Shirley loved to hunt, and enjoyed the woods of Nova Scotia. They spent many hours driving Robbie's specially equipped vehicle to Patricia, Korea veteran and Legion functions. We got to know the familiar sight of Robbie pulling up in the van, Shirley digging out the wheel chair, and joining the boys for the functions. None thought of him as handicapped, but all who served knew deeply what he sacrificed.

He was proud to be in the parades, and many were proud to assist him. He gave the eyes right and salute smartly to his Colonel-in-Chief and his Regiment.

We won't see that any more. Robbie died April 28, 1993.

Robbie was the spirit of our Regiment to all of us, we were honoured to know him.



#### I CALL TO ORDER

1. The President called the meeting to order at 0900 hours and welcomed all members present. He then formally introduced the executive members and made special comment to the fact Colonel Gray, Vice President of the Regimental Guard and Lieutenant-Colonel Pentney, Chairman of the Regimental Executive Committee had both taken time from their busy schedules to attend the Annual General Meeting. The President then asked all to observe a minute of silence for departed comrades.

#### II QUORUM

2. The President noted that a quorum was present.

#### III APPROVAL OF AGENDA

3. The President asked for a motion for the approval of the agenda that was circulated to all branches prior to the meeting.

Motion: Moved by J. DeBruyne, seconded by L. Jones that the agenda as circulated be approved.

#### Carried

#### IV APPROVAL OF MINUTES OF 44TH ANNUAL MEETING

- 4. The President informed the members that copies had been circulated in the Newsletter and asked members to review the minutes for omissions or errors. Members made the secretary aware of minor errors and omissions that would be corrected.
- The President asked for approval of the Minutes of the 44th Annual General Meeting.

Motion: Moved by A. Shane and seconded by K. Barwise that the minutes be approved as amended.

#### Carried

#### V REPORTS

6. <u>President's Report</u>. This has been an eventful year for the Regiment and the Association. Our Third Battalion have recently returned home from a six month tour in Croatia and have begun down-sizing in preparation for the move to Chilliwack and their new 10/90 role. Second Battalion have taken their place in Croatia and the First are preparing for their tour in 1994.

Since our meeting in Stoney Creek last year, I have attended meetings of the Regimental Guard in Calgary and Winnipeg and the Regimental Executive Committee in Ottawa and Wainwright. The Trustees of the Hamilton Gault Memorial Fund have met twice, and the Regimental Heritage Committee have also had two meetings. Members of the Association Executive and the Calgary Branch, together with RHQ and First Battalion, have begun planning for the 80th Anniversary Reunion in 1994. Other members of the Association have been involved in preparing a campaign to restore the Victoria Cross, reviewing the Constitution, conducting the 1992 Cash Casino and preparing for another this year, and working as tour guides in the Museum. Several branches have been sending books and other items to the troops in Croatia and providing support to their dependents. And not least, the time and effort members of the Okanagan/Thompson have put into planning and preparation for this weekend's activities.

The 1992 Cash Casino was highly successful, raising \$32,000 for the Museum. We intend to repeat this event in each of the next four years.

The matter of the Victoria Cross has been resolved with Ottawa's announcement in February of a new series of military awards for gallantry, including a Canadian Victoria Cross as our highest military award.

Bill Love, Vice President East, has been reviewing our Constitution and his observations and recommendations have been presented to Council for review.

The Certificate of Merit, posthumously awarded to Les Basham at the Fourth Annual Meeting of Council in May, 1991, was presented to his widow, Muriel Basham, by the Colonel of the Regiment at the Vancouver Branch's Annual Regimental Day Luncheon on March 14th of this year. I have since received a letter from Muriel expressing her sincere appreciation.

Good Progress has been made during the past year towards completion of the Patricia Gallery of the Museum of the Regiments. The gallery is approximately 50% complete and plans are underway to raise the remaining \$250,000 needed for completion in time for the 1994 Reunion.

I am pleased to report the term of Major-General Pitts as Colonel of the Regiment has been extended and he will hand over to his successor during the 80th Anniversary Reunion. The Colonel-in-Chief will preside over the hand-over.

The Regimental Heritage Committee held their 3rd meeting on March 9th in Calgary. They have now agreed upon their Terms of Reference, which were subsequently approved by the Regimental Executive Committee on May 19th, and have developed Standard Operating Procedures. Within the next few weeks, I will provide Branch President's with instructions regarding the appointment or election of Branch Heritage Coordinators to work in direct support of the Regimental Heritage Committee.

The Militia augmentees serving in our battalions are eligible to be members of the Association and I have asked our Battalion Commanders to make them aware of it before they finish their tours and disperse. The battalions have agreed to assist, but it will also be up to branches to go after Militia men and women in their areas who have served with the Regiment.

A new medal has been authorized for overseas service in areas such as Germany for which there is no specific medal. RHQ has not yet received the details, but we will pass on the information as soon as it becomes available.

The 6th Annual Meeting of the PPCLI Association Council was held in the Camp Vernon Officers' Mess on June 4th, 1993. The audited Financial Statements of the PPCLI Association Operating Fund and the Hamilton Gault Memorial Fund for the year ended December 31, 1992 were approved. Council also approved 1994 Budgets for the PPCLI Association Operating Fund and the Hamilton Gault Memorial Fund. The accounting firm of Ernst & Young was selected as the Auditor of Choice for FY 1993, provided they will agree to our financial terms. If not, the firm of Price Waterhouse is recommended. In addition, Council recommended amendments to the Constitution appointing the Vice President of the Regimental Guard to the Association Council and empowering the Vice President of the Association to succeed if the President is unable to continue in office. Council also agreed that the Fiscal Year End should be changed to April 30th, if necessary enabling us to pay lower auditing fees.

#### VI FINANCIAL REPORTS

- 7. <u>Auditors Reports</u>: The Treasurer presented the 1992 Financial Statements for both the Association Operating Fund and the Hamilton Gault Memorial Fund dated for year ending 31 December 1992. (Annex A)
- 8. Mr. Raidt questioned the move of museum artifacts from the Association Operating Account to the Hamilton Gault Memorial Fund and under whose authority this took place. The Secretary stated the move of artifacts to the Hamilton Gault Memorial Fund Museum Account was done after the Stoney Creek Annual General Meeting 1992. It was pointed out by Council that they were not satisfied with the Association Account not being audited. The RM expressed at that time that the only way they could receive an audited statement was to have the artifacts appraised and valued. Throughout the remainder of the year Museum NCO working with local appraisers and collectors established an acceptable value for our artifacts.

- 9. The artifacts were then capitalized with the Auditors to properly account for them and it was at this time that the artifacts were moved to the Hamilton Gault Memorial Fund Museum account where they properly belong IAW by law number 5 section 3 Hamilton Gault Memorial Fund para 5.14 (1) (a).
- 10. Some discussion ensued with the President concluding that he is satisfied with the operation of the Funds, including the current balances and liabilities. The President asked for a motion that the 1992 Financial Statements be accepted.

#### 11. Hamilton Gault Memorial Fund Financial Statements

The policy as set out in the Constitution and Bylaws states that all dues must be paid by 31 March of that year.

#### IX MUSEUM REPORT

17. LCol Pentney presented the members with an update on the PPCLI Gallery. He explained the fundraising initiatives that were presently being carried out and when and how the completion of the exhibits would take place. All members were happy with progress to date and are eager to see completion in time for the 80th Anniversary Celebrations in 1994.

## **AUDITORS' REPORT**

#### To the Trustees of the Hamilton Gault Memorial Fund

We have audited the balance sheet of the Hamilton Gault Memorial Fund as at December 31, 1992 and the statement of fund activities and fund balances and changes in financial position for the year then ended. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many charitable organizations, the Fund derives part of its revenue from donations and fund raising activities which are not susceptible to complete audit verification. Accordingly, our verification of revenue from these sources was limited to a comparison of recorded revenue to bank deposits and we were not able to determine whether any adjustments might be necessary to donation revenues, excess of revenue over expenditures, assets and fund balance.

During the year, the organization recorded museum artifacts transferred from an associated charity at the associated charity's recorded value of \$395,464. This recorded value has never been subject to audit and we have been unable to obtain sufficient appropriate audit evidence to substantiate this recorded value. In addition, museum artifacts donated by third parties during the year have been recorded at a value of \$90,608. Generally accepted accounting principles require that donated assets be recorded at fair value when fair value can be reasonably estimated. Recent independently prepared valuation appraisals have not been provided by the organization or the associated charity to support the recorded value of the donated assets. As a result, we were not able to determine whether adjustments might be necessary to donation revenues, excess of revenue over expenditures, museum artifacts and fund balance.

In our opinion, except for the effect of adjustments, if any, which we may have determined to be necessary had we been able to verify the completeness of revenue and verify the recorded value of the museum artifacts donated by third parties and the museum artifacts transferred from an associated charity, these financial statements present fairly, in all material respects, the financial position of the Fund as at December 31, 1992 and the results of its operations and changes in its financial position for the year then ended in accordance with generally accepted accounting principles.

#### 1. Accounting Policies

#### (a) Museum assets

Expenditures of a capital nature are expensed except for museum artifacts and museum displays and statues. Museum artifacts and museum displays and statues are recorded at cost and are not depreciated.

#### (b) Donated museum assets

Donated museum assets are recorded at fair value on the date received and when the fair value can be reasonably estimated.

#### 2. Change of Accounting Policy

In 1992, Hamilton Gault Memorial Fund changed its fixed assets accounting policy, on a retroactive basis, from expensing all capital asset additions to capitalizing only museum artifacts and museum displays and statues.

The effect of this change in accounting policy, on the December 31, 1991 financial statements is summarized as follows:



This cartoon depicts the late Capt Owen Gardner, then RSM, in about 1950, when he first caught sight of Dick Roberts, who he had not seen since Godstone in 1940. After the war, Roberts had been awarded an H3 category; unfit, mercifully, to tumble out of aircraft; but fit, again mercifully, to tour the countryside in a tank. This ribald remark refers to the pre war days when A Coy Patricia's and A Sqd Strathconas, (then cavalry) shared Fort Osborne Barracks together. This was a very dull remark compared to some in those days between the two groups.

## PRESSED INTO COMMAND

# THE STORY OF PRIVATE LLOYD KREAMER

Four days a platoon commander. Such was the record of Private Lloyd Kreamer of Netley Lake, as the Princess Patricia's Canadian Light Infantry (PPCLI) of Winnipeg fought the battle of the Marecchio bridge-head.

Kreamer had given up diamond drilling at the Pickle Crow mine to become a sniper-scout with the western regiment, but in the vicissitudes of army life he once attained status of corporal but the chevrons were transient and Kreamer went into the battle a private. However, it wasn't long before life became unexpectedly complicated for at the Ausa crossing - the "Pats" ran afoul of a shelling tornado which churned up the river valley, tore companies apart and wrecked their organizations. Sergeants took over from wounded officers, corporals from sergeants and privates were pressed into higher duties.

In the re-organization of B and D companies into a composite fighting team, Kreamer was borrowed from the sniper-scouts and given charge of a section just as a shell exploded squarely in the middle of the trench, killing two, wounding three which included a sergeant and putting six more out of action. Kreamer, the senior private among the nine remaining, was only four feet away when the explosion occurred and found that when he was able to climb back to his feet that he was the platoon commander.

Recalling the incident, Major Sam Potts of Saskatoon, said that in a matter of ten minutes Kreamer had supervised the evacuation of the wounded, reorganized the men into a two section basis and reported to the company commander that the platoon was once again, "OK and ready to go!" That night the "Pats" crossed the Forunasto Ridge and went into the main attack on the Maracchio. Except for a brief interval as platoon sergeant, Kreamer never relinquished command and finally had the satisfaction of leading his men onto the bridgehead.

His company commander credits him with faultless handling of his platoon and a job of work fully comparable with other platoon officers. In the ranks Kreamer had acquired a few ideas of his own and when his objective had been captured he established headquarters in a wrecked farmhouse and set up an all-round defence and then for a "treat" and an antidote to the shell and rifle fire and the long hard day, he organized the liberating of an Italian pig for a roast pork banquet.

"Better than a picture show," was Kreamer's description of an incident involving one of his men, private George "White Boy" Bowles of Brandon. An individualist in matters of warfare, Bowles spotted two German vehicles, a jeep followed by an ambulance lorry turning the bend in the road. Running out in his stocking feet he waved at the drivers shouting, "Bona Bona". Both drivers immediately went into reverse, crashing into one another and plowing full speed in and out of ditches in a desperate bid to escape the apparition in stocking feet. The two Manitobans, shaking with laughter, watched them disappear back down the road.

One citation for the Military Medal (MM) which Lloyd Kreamer, who still resides near Netley Lake, received reads in part as follows: "In January 1940, this non-commissioned officer joined the PPCLI as a private. He landed in Sicily in "August 1943 and since then he has been with his unit in all actions in the Italian campaign, his conduct throughout has been of the highest standard of gallantry and efficiency. During the battle for the Hitler Line he particularly distinguished himself. In addition to carrying out his normal duties, he worked until well after dark under the most intense fire and in unswept minefields bringing out casualties.

On September 20, 1944 in the fighting after the Gothic Line break-through, the PPCLI attacked in the area of II Castellaccio. Sgt Kreamer's platoon came under an intense artillery concentration causing 11 casualties, amongst whom were the platoon commander and all of the non-commissioned officers. Private Kreamer, as he then was, and who had just taken over a section, immediately took charge of the platoon. Still under very heavy fire, he revised the plan and led his two sections in a determined and successful assault to the objective which they held in the face of a strong German counter-attack, He remained in charge for the next four days, during which time his bravery, cheerfulness and leadership inspired his small handful of men to complete success in all of their operations.

"In this and in subsequent actions of the Savio River and Canale Naviglio, Sgt Kreamer was one of the mainstays of his company. By his unselfish gallantry, good humour and devotion to duty he has contributed in large measure to the success of his battalion."

When asked about snipers, Kreamer said that you'd never find a more colorful swash-buckling crew on the Eighth Army front than those devil-may-care individuals. They lived by their wits, fighting a personal sort of warfare. They play for keeps, betting everything on their own skill, fieldcraft and deadliness with the sniping rifle. Kreamer sore by his Breda and said that there was no lack of ammunition for it because the German army supplied. All scouts converse freely in Italian and ten different languages are spoken by men within the platoon. Canadian German speakers were most often used in order to get out of some potentially dangerous corners by their quick and easy command of that language was never challenged by the enemy.

A small new item written by a Winnipeg new reporter reads: "Sgt L. Kreamer of Netley Lake, Manitoba said he'd like to "sleep for about five years in my own bed once more." He hadn't slept in that bed for six war years during which time he had served Sicily, Italy, France, Belgium and Holland. He was wounded in the leg at Altona in December 1943. His parents met him at the station.



## JUST A COMMON SOLDIER

He will not be mourned by many, just his children and his wife,
For he lived an ordinary and quite uneventful life.
Held a job and raised a family, quietly going his own way.
And the world won't note his passing, though a soldier died today.

If we cannot do him honour while he's here to hear the praise
Then at least let's give homage at the ending of his days.
Perhaps just a simple headline in a paper that would say,
Our Country is in mourning, for a soldier died today.
