Student Bursaries

Help at Home for More Veterans' Survivors

The Minister of Veterans Affairs recently announced that survivors and, in cases where there is no survivor, other primary care-givers of deceased Veterans may be eligible to receive **for life** housekeeping and/or grounds maintenance services under the **Veterans Independence Program (VIP)**.

The Veterans Independence Program, a national homecare program administered by Veterans Affairs Canada, makes it easier for veterans to live independently in their own homes by providing financial support for items such as snow removal, lawn mowing, etc.

In the past, when the veteran died the widow or other primary caregiver would receive the assistance for one year after his death. In June 2002, coverage for housekeeping and grounds maintenance services was extended to Veterans' survivors for their lifetime **effective from that date forward** in cases where these services were required to remain self-sufficient at home and providing the Veteran had been in receipt of them at the time of death. Now, with the Minister's recent announcement coverage for the two services is extended to eligible survivors and other primary caregivers of Veterans **who had been receiving VIP benefits and passed away before June 2002**.

To qualify, survivors and other primary caregivers must be assessed as requiring the housekeeping and/or grounds maintenance services due to health needs and to remain independent at home. The Veteran must have been provided with these services any time after September 1st,

1990 and have been receiving them at the time of death. Primary care-givers must also demonstrate that, at the time of the Veteran's death, they maintained or were maintained by the Veteran, they were residing with the Veteran, and they were the adult primary care-giver of the Veteran and were not receiving wages for providing that care. Payments will not be retroactive.

Survivors and other primary caregivers of a Veteran who died after September 1st, 1990 and within one year of being admitted to a long term care facility may also be eligible and will be required to undergo a similar assessment.

Veterans Affairs Canada (VAC) is planning an information campaign to reach eligible survivors and ensure that those who qualify start getting support as quickly as possible. VAC will start contacting by mail those survivors who formerly received these services to determine if they qualify. Survivors who think they may be eligible and other primary caregivers who may qualify should call 1-800-443-0382 (toll-free) for information on how to apply for housekeeping and/or grounds maintenance services.

Gas Pumps and Cell Phones Incompatible

Shell Oil recently issued a warning in which cell phones ignited fumes during fuelling operations.

In one case the phone was placed on the car's trunk lid during fuelling. It rang and the ensuing fire destroyed the car and gasoline pump. In another case an individual suffered burns to the thigh and groin as fumes ignited when the phone, which was in his pocket, rang while he was fuelling the car.

Mobile phones should be turned off or left in the car when at a filling station or around other materials that produce flammable or explosive fumes.

Greetings. Although reminded that the Association Bulletin is intended solely to update members on previously announced events, I did not want to miss an opportunity to pass on a comment (my apologies to the President).

The celebrations for the 90th Anniversary of the Regiment are fast approaching. The planning team from the battalions, RHQ and the Association has been working hard to develop events that will allow all current and past serving members of the Regiment an opportunity to come together to celebrate. I believe we are putting together a good package. The events in Winnipeg are being staged in conjunction with the Battalion's farewell to the city prior to its move to Shilo this summer. The activities are designed to mark the anniversary and acknowledge the strong relationship with the city. The activities in Edmonton are designed to celebrate the Regiment's anniversary and mark the 100th anniversary of Edmonton and St Albert. The Army, and specifically the Regiment, have benefited from a recently renewed awareness and appreciation by the general public and it behoves us to maintain the connection with the public. Strong bonds with the community from which we depend on for support and future recruitment are essential. This is one reason why the decision was reached to celebrate our anniversary in public venues in conjunction with community-related celebrations i.e. to not only celebrate amongst ourselves but with the communities that we ultimately serve.

THE ASSOCIATION BENEVOLENCE INITIATIVE

The 2003 AGM proposals.

At the 55th Annual General Meeting held in June 2003 in St. Catharines, the Ottawa Branch proposed an approach to help our retiring soldiers, retirees and their survivors adjust to changes in their lives that challenge their well being in any way. The Branch was tasked to report to the Association Executive and the Regimental Guard in November 2003 with a view to presenting a comprehensive proposal to the 56th AGM in 2004.

What will the Association be doing?

The best way to explain what the Association will be doing to help our members is by drawing a parallel with the leadership model of '*Letting it happen, helping it happen and making it happen*'. By *letting it happen*, we mean that established agencies, whether federal, provincial, municipal or non-governmental would provide the support our people need to adapt to change. We do not intend to create a new organization to compete with the Legion or any other caregiver. By *helping it happen*, we see the Association providing information and advice to members on established programs and referring our people to the right agency and person. This will be done through an improved website and to newsletters and by a call-in service staffed by volunteers to answer specific questions and help members to identify and contact the right program and agency. Finally, for those individuals having difficulty finding support, we see a core of caseworkers at the national level *making it happen* by helping people make their case to established agencies, or finding help when no agency exists. Our review indicates that the greatest need may be with those who face a major change such as premature release for medical or administrative reasons, or for survivors on the death of a serving or retired soldier. These individuals or families are often faced with multiple problems that can last for a protracted period. How we help these members of our family will probably require a different approach from the single person - single problem case. We are now looking at how we can establish and sustain these two forms of support; one focussed on individual single issue problems and a second focusing on broader needs during a time of major change.

Who is going to do all this?

To take both geography and demographics into account, we will be recommending that the introduction of the

initiative begin with the least demanding form of assistance: the provision of an information and referral support to retirees, families and survivors. To do this we will probably require a core of two or three caseworkers, likely in Ottawa and the West with good access to supporting agencies and communications. Branches will likely be asked to help, consistent with their capabilities.

How much will all this cost?

There are some costs involved in setting up and operating the initiative. Start-up costs should not exceed \$2,000 over two years. Operating or variable costs are largely related to communications. If the Association decides to provide a 1-800 call-in service, annual communications costs could be in the range of \$2,500-\$3,000. Other operating costs could add another \$500 or so. Without a 1-800 service and with volunteers and branches absorbing their own expenses, annual operating costs will likely not exceed \$500-\$1,000. We are also looking at fund raising to offset these costs and we are confident that the positive goals of the program will help us find funds more easily. Cost estimates and funding options will be presented to the AGM for decision.

What will be presented at the AGM?

The Council will be given one or two options on the way to proceed, subject to budgetary limitations and the supporting governance and organizational arrangements. Once approved by Council the membership will be asked to sanction the program.

THE SILVER (MEMORIAL) CROSS

Each year the Royal Canadian Legion chooses the National Silver Cross Mother to represent the mothers of Canada at the National Remembrance Day Ceremony in Ottawa on November 11 when she will lay a wreath at the base of the National War Memorial on behalf of all mothers who lost children in the military and Merchant Navy service of the nation.

The last two National Silver Cross Mothers were the mothers of Patricia's killed while on duty with 3 PPCLI Battle Group in Afghanistan in April 2002. Mrs. Doreen Coolen of Simms Settlement in Hubbards, Nova Scotia, mother of the late Private Richard Anthony Green, was the National Silver Cross Mother in 2002; and Mrs. Charlotte Lynn Smith of Tatamagouche, Nova Scotia, mother of the late Private Nathan Lloyd Smith, in 2003.

During the past few months we have been informed of awards of Memorial Crosses to family members of two Patricias who died while on UN service in Cyprus: Master Corporal J.D.G. McInnis, 1 PPCLI, 30 March 1980 (See **Atlantic Branch**, following this item); and Private Alan Prins, 2 PPCLI, September 26, 1982 (See **Association Newsletter**, November 2003).

As this award is unfamiliar to many of our members, it seems appropriate to include some background, provided by Bill Minnis, Atlantic Branch President, based on case notes compiled by Capt Carl Gauthier, DHH 4 Admin O at DND.

The Memorial Cross was approved in 1919 for those "who died in the war or as results of wounds received during the war". It was revived in 1940 with the same wording.

It was again revived in 1950 with the wording changed to "for personnel **killed in action**, or died while proceeding to or returning from an area of hostilities outside Canada in consequence of any action undertaken by Canada under the UN Charter, the North Atlantic Treaty or any other instrument for collective defence that may be entered into by Canada".

It seems it was modified again in 1966 to read "who have **laid down their lives for their country** whilst in, or proceeding to or returning from, an area of hostilities outside Canada, or who died of **causes attributable to service** in such areas, in consequence".

Between 1950 and 1993, other than a few exceptions, there was no real effort to identify casualties who met the criteria for the Memorial Cross.

In Feb 1978, responsibility for administration of the Memorial Cross was transferred to the Department of National Defence (DND) and, from 1993, DND started to issue them again, but only for those personnel who met the restrictive interpretation of "**attributable to service**" (i.e., no suicides, accidental or natural deaths).

In March 2001, the policy was changed to include all deaths in a Special Duty Area, whatever the cause, as it was felt that every member of the Canadian Forces is deployed there for reasons attributable to service. Accordingly, it was decided to go back in time and trace all personnel who died while serving in a Special Duty Area.
