My Dear Patricias,

On this 75<sup>th</sup> Anniversary of our Association, I want to give you best wishes and congratulations from the bottom of my heart. It was 75 years ago when Hammy Gault acknowledged the value and importance of bringing together the various service clubs and the PPCLI Wives Club. He recognized that veterans and all like-minded persons wanted to continue their affiliation with our beloved Regiment and he wanted to give us the means to maintain our contact and interest with each other and also with those still in service.

Since the early days of World War I, former serving soldiers had managed to maintain ties with each other and they continued to provide support by various means to all those who were still serving at the front. This continued service carried on throughout the years between the wars and then throughout World War II.

The logical extension of this strong desire of those who had served wanting to remain connected to those in uniform meant the establishment of the formal organization of the Association in October 1947. And it was

Hamilton Gault himself who included the PPCLI Wives Club as one of the fundamental components of the Association.

Spouses have always been recognized as an integral part of the Regimental Family and a vital component of our Association. The Regiment has always been at the forefront in the fight to protect, promote and project democracy around the globe over decades of service. And since 1947, the Association has supported the Regiment in doing this. During periods of armed conflict, during the prolonged Cold War and through the lengthy time of peacekeeping and peace enforcement, the Association's members have played a role while in uniform and following active service.

Now we are faced with the horror and devastation of an unjustified war against the Ukrainians. We do not know what we as Patricias may be called upon to do while challenged by this violence. But I am confident that the Association will continue to prove that they will support whatever role our soldiers are called upon to perform. As we face this devastating war in Europe in our 75th year as a family organization, I know that you will take to heart the model which we all hold dear: "Once a Patricia, always a Patricia".

The Association has a long history of providing a social and informational support focus for Patricias and their families, and more than that. Hamilton Gault was voicing the need to look after every wounded veteran properly to the Canadian public as early as 1917: "*many of them [the soldiers] come back dismembered and maimed for life. I only hope that in the enthusiasm of their return your generosity will not be forgotten in the years to come. . .* "He was an avid supporter of the Returned Soldiers leagues and initiatives. In 1925 there was a seminal meeting in the Marlborough Hotel Winnipeg, often home to the Manitoba/NW Ontario branch events later, where the bases of the Canadian Legion were laid. By 1926, Hammie was the Canadian Legion's representative on the British Empire Service League's Council. He had also had a hand in creating the PPCLI Service Clubs which dated from 1919. And, as we know, those Clubs and the parallel Wives Clubs were unified into the PPCLI Association, in October 1947, which dates the current Association's legal birth.

- And so, Happy 75th Anniversary to all "Once a" Patricias. -

One of the enduring roles of the Association has been communications. I recall Vern Cole, a legendary Regimental Adjutant (and also, simultaneously, the Association Secretary) who would type up mimeographed and highly informative newsletters and mail them out to everyone round the globe. Gawd...even that form of communication helped glue the regiment together. The Association was no small thing then, and is not today. It effectively extended the camaraderie of service post-separation from the Canadian Army. It also cried out for

support for the wounded and the disabled. The structure of the Association reflected the approach of the British War Services clubs – physical branches in meeting places, largely centered on democratic meetings and group activities, mutual support and less seriously the taking of grog and the telling of tales. Some of that is now moot, with less tolerance for bedlam and instant comms - Instagram, Facebook and emails. We are pretty steady at 1000 in the formal structure, 5000 in the Association Facebook group, and outside that, some dozen other groups of Patricias choosing to rally separately.

The establishment of the Volunteer Patricia Programme (VPP) in the early days of the Afghanistan war took the Association out of its traditional (since Korea) box. The money to begin the first effort which led to OP Small Pack and VPP - provided a package of goods that a soldier wounded and in hospital might use – razor to track suit. That money was raised in a very short time by an on-line appeal within the Regiment, and the programme was soon taken over by the CF.

That first effort has expanded as the operational stress impact of 13 years in Afghanistan after a decade in the Balkans, became apparent to all again, as it had after each previous war. The very nature of posttraumatic stress, long term in its impact and debilitative, has demanded complex and widespread treatment and assistance programming. Many Canadian service personnel, including many Patricia's, suffered and still suffer. The need for peer support structures and practices remains high.

This work by the PPCLI Association across all its years and including its early predecessors, deserves the support of us all. The history of 75 years and more provides a very clear purpose for the continued relevancy of the Association today. It has been and will continue to be, with the other themes of generosity of purpose and spirit in the Association's activities, transformative.

#### The National Presidents' Message

COVID-19 did more than just strain us this past year. It has also interrupted our annual general meetings over the past two years. Unfortunately, despite the current easing of restrictions, a decision had to be made early regarding this year's AGM. The Board of Directors determined that yet another virtual AGM was necessary given the uncertainty and instability of the COVID-19 virus. So, sorry to say, the Saskatchewan Branch will once again miss out hosting the event. Details of the virtual AGM which will be held on 28 May appear later in this newsletter.

The Association has embarked on two major projects: a record-keeping overhaul and a new website. While neither one of these projects are jazzy, both are critical to the efficient running of the organization. The record-keeping project will see the creation of a new database with better privacy protection measures in place. The new website will enhance our communications both internally and externally.

Four new Directors will hopefully be added to the Board of Directors at the AGM. The Board, for those who don't know, is the group of individuals (up to 13) who have agreed to step up into leadership roles. An organization is only as strong as those who are willing to take on the responsibilities needed to run the organization. The Association has been fortunate to have had many dedicated people serve on the Board in the past. Unfortunately, it's getting more and more difficult to find individuals willing to volunteer to be on the Board or in Branch executives. I'm not sure of the reasons, perhaps second careers, other volunteer positions or family commitments prevent many from stepping forward. I get it - there's a lot going on, even in retirement. The trouble is, if we don't attract good people to lead the organization, the Association's future could be jeopardized. I appeal to all members to consider taking on leadership roles at the Branch and National level. You and the Association will be better for it.

On that note, I will say that I am putting my name forward at the AGM for election to the President's position for one additional year. Assuming I am extended, I will serve as your President until AGM 2023. It has been my privilege to have served in this capacity. I thank everyone, particularly the Board of Directors, for their support.

#### Hamilton Gault Memorial Fund



It has been just under a year since the formal separation of the Hamilton Gault Memorial Fund (HGMF) and the PPCLI Association occurred. That separation was necessary to protect the charitable status of the HGMF; however, the cooperation between our two entities has not changed. We still work cooperatively, albeit a bit more formally, to support the Regimental Family.

We have established memorandums of understanding (MOUs) to deliver the bursary program and support cadets. We also developed one that supported the Southwest Ontario's initiative to create a monument at the gravesite of Jack Munroe, one of the Originals.

The HGMF is supporting the delivery of two Compassionate Listening Workshops this year. This is an important addition to the peer support toolbox that Volunteer Patricia Program Coordinators and those with mental health training are encouraged to take advantage of the workshops.

## **Charitable Activities and Fundraising**

The HGMF was established in 1964 with the initial purpose of providing educational bursaries for serving members so they could improve their education. Since then, our charitable activities or object have evolved. We currently;

- Provide educational bursaries which has been expanded to include both serving and retired or released Patricias and their descendants,
- Support 11 PPCLI Cadet Corps in Western Canada,
- Maintain Regimental Memorials such as Frezenberg, Patricia Park and Lansdowne,
- Memorial Fund Peer Support workshops,
- Support other agencies who help Veterans and their Families, and
- Assist with home modifications not covered by Veterans Affairs Canada.

This is a breakdown of charitable activities the HGMF supported in 2021 and what is planned for 2022.

## **Tax Refunds for Charitable Donations**

Your charitable donations entitle you to a two-tier tax credit. The first \$200 of annual donations results in a 15% federal tax refund, plus the applicable provincial refund. Donations above \$200 yield a 29% federal tax refund, plus the provincial refund. The combined Federal and Provincial Tax refund for donations using the Canada Helps calculator for donations of \$100 or \$1000 are shown below:

## **Planned or Legacy Giving**

There are many ways you can help Veterans and their Families. One of these is by Planned Giving or simply explained as a bequest in your will, a percentage of your life insurance policy or a request for people to make donations to the HGMF after you pass away. The size of your gift or bequest is how much you wish to donate from your estate. It can range from \$500 to \$5,000 or more is you wish to create or contribute to an existing endowment fund. The annual investment from this type of fund would support the HGMF's charitable activities or objects. Your estate will receive a tax receipt for the full value of your gift or bequest.

## **Future Fundraising Activities**

We are planning to continue the Regimental Anniversary Bike Ride fundraiser. Last year we raised \$14,734 with 21 participants. This year the ride will take culminate on Sunday 7 August 2022 and we hope to have at 50 participants and double what was raised last year. The format will be the same as last year. You do not have to ride a bike 108 km. You can do any activity of your choice, while you ask others to contribute to a worthwhile cause.

#### Sydney Frost Commemorative Battlefield Tour

We have delayed the Battlefield Tour to May 2024 because of the challenges of conducting the recce this year. As part of this tour, we plan to include a Cadet Youth Education Program with the aim of educating young Canadians on the sacrifice made by previous generations of Canadians, while enhancing their understanding of World War II. We will require the Cadets to research a Canadian who made the ultimate sacrifice in Sicily or Italy during World War II and brief tour participants on that soldier as they stand by their headstone. We intend to host cultural exchanges between Canadian and Italian youth during various parts of the Battlefield Tour such as Ortona and the Hitler Line. This is an excellent opportunity for youth to learn citizenship, discipline, teamwork, and comradery, as well as learning something of Canada's rich history while meeting with Italian youth.

The PPCLI Association membership is our primary donor base. We sincerely thank those members that have supported, and continue to support, the HGMF and its activities through their donations. The easiest way to support the HGMF is through a regular, monthly donation using Canada Helps. We encourage members of the Association to consider this option.

#### The PPCLI Association and the Patrician

The Princess Patricia's Canadian Light Infantry (PPCLI) Association informally dates back to World War One. The original association of former PPCLI members was called the "Princess Patricia's Canadian Light Infantry Service Club," with its first annual dinner held in 1919. Numerous post World One Patricia clubs were very much involved with the Regiment, fostering new and maintaining existing relationships but eventually this scenario began to diminish.

At the outbreak of World War Two, interest was rekindled and by 1942, the various surviving Patricia Clubs across the country were again active, including Wives Clubs, in supporting the PPCLI battalion overseas. The Esquimalt and Winnipeg clubs were most notable in their dedicated efforts supporting the Regiment throughout the war by fundraising and sending comforts overseas while aiding wounded Patricia's on their return home.

After World War Two, under the initiative of a new "call to arms" and leadership by the founder of the Regiment, Brigadier A. Hamilton Gault, DSO, ED, a committee was formed. This resulted in all the remaining Patricia Clubs and Wives clubs formally being organized into the "PPCLI Association" on the 24<sup>th</sup> of October, 1947, in Calgary.

Next came official incorporation, and on September 1<sup>st</sup>, 1953, the "PPCLI Association" was incorporated. This is where *The Patrician*, established in 1933 at Esquimalt with publications suspended in 1939, and the Association, became connected. Revived in June 1953, *The Patrician* contained a brief history of the Association's beginning, and a section of the journal to be dedicated to "the old PP's," with PPCLI Association content to be regularly featured. The November 1953, *The Patrician* provided organizational details of the incorporation.

In 1959, under a new format, *The Patrician* continued to include input from and references to the Association, its individual branches both in Canada and abroad. PPCLI Association members have continued to contribute to the various jurisdictions included in *The Patrician* to this day. ## **Greg Ferguson**



Greg joined the Canadian Armed Forces in December 1980 and after completion of recruit training in Cornwallis he went to Battle School in Wainwright with Gully Platoon. After Battle School he was posted to 1 PPCLI. He participated in all the annual exercises including some unique experiences in Alaska where the company set the record for ascending the local mountain. Another memorable experience was in Canada's north as a participant of Exercise Sovereign Viking (and I still have the t-shirt). In 1983 he remustered to Military Police and was sent to Camp Borden to complete TQ3 MP.

After completion of MP training he was posted to CFB London Wolseley Barracks MP Detachment. In 1987, Greg deployed to UNFICYP and UNDOF as a member of the UN

Military Police contingents. He left the military in 1989 as a Corporal and pursued a career in Occupational Health and Safety. He is currently as a member of the Ontario Public Service as a Health and Safety/Emergency Coordinator with the Ontario Clean Water Agency. As a member of the local volunteer Fire Department, Greg rose to the rank of Lieutenant prior to retiring from that position. In 1993 he married Tracey who despite the ups and downs of life remains his best friend. He has 3 grown adult children who are his penance for his youth. Greg joined the Association in 2013 and has been actively involved ever since, serving as President of the SW Ontario branch since 2018. As a person who has struggled with Mental Health issues, he is passionate about providing support to fellow veterans in any way he can.

## **Fred Horsman**



Hello, my fellow Patricias: I began my journey in 1973 and release in August of 1978. I did a tour as a UN peacekeeper in 1976 with the second battalion. My journey began in 1977 when I went home for a month. My mother knew that something was different about me. She contacted the military about help and the Royal Canadian Legion and Army/Navy/Air Force, but no one was willing to help me. I realized that no one would assist me so I began the healing journey myself. I became a layman expert in PTSD and taught numerous programs with grief recovery, suicide, and violence programs. My commitment is to all military personnel, that you do not have to journey down the same path.

## **Gordon Keener**



Gordon Keener was born in Williams Lake and grew up on the ranch where he and his wife Terry now live. He joined the Canadian Military and started basic training in Cornwallis on February 25, 1982, after which he completed Infantry training at the PPCLI Battle School and was posted to 3 PPCLI in Sept 1982. In 1984, he was posted to Wainwright and joined the Base Rifle Team and after a short period he returned to 3 PPCLI where he was a member of the Bn Rifle Team and Corps of Drums. He did a tour in Cyprus in 1988 as NCO IC of the ambulance section and then served for one year with the Canadian Forces Medical Services.

After leaving the military in 1990, Gordon worked in the hazardous waste industry in the Lower Mainland as a Project Manager overseeing projects for school districts, BC Hydro, BC Ferries, Vancouver General Hospital, a Ship

building company and others. He returned home in 1997 and worked with the Xatśūll Heritage Village. In 1998, he started working with Northern Shuswap Tribal Council and became a member of the Treaty Team at Dog/Canoe Creek as the Self Government Co-ordinator. In 2003, Gordon returned to Soda Creek as the Self Government Co-ordinator and is now as the Treaty Manager and Negotiator. He worked with his wife Terry in developing sustainable agriculture on their ranch. For the past several years he has worked with the Cariboo Growers Co-op where he was president. As a Veteran, he worked with the Royal Canadian Legion and was President for two years. He is a volunteer Service Officer and 1<sup>st</sup> Vice President. He currently sits on the CRD Area D, Area Planning Commission as well as Thompson Rivers University Industrial Advisory Board for developing curriculum for sustainable agriculture. Gordon also works with the BC Ministry Justice as an on-call Child Protection Mediator.

## **James Byron Stanton**



Jim served in the Canadian Armed Forces from 1957-1984 with the PPCLI and as a Class A and B reservist. He has maintained his military connections as a member of the PPCLI Association, Airborne Association, King's Own Calgary Regiment Association, Royal Newfoundland Regiment Advisory Committee, and BC Regiment Association.

He is a member of Royal Canadian Legion, Royal United Services Institute-Vancouver, where he served as President, Vice-President and Director, and of the Royal Canadian Military Institute, Toronto.

Jim was one of the founding members of Honour House BC, a home away from home for veterans and first responders and their families requiring medical treatment in New Westminster BC. He was awarded the Minster of Veterans Affairs Commendation in 2012 for his work with numerous veteran programs.

A graduate of Simon Fraser University, Jim worked as a journalist with the CTV network after leaving the military. He then became the Director of Communications and Director General of Government Relations for Canada Post before setting up Stanton Associates in 1990, a communications and training company with offices in Canada and the USA.

Jim is well known in the communications and emergency preparedness community, where he has assisted in developing proactive communications strategies to deal with floods, plane crashes, forest fires, the Kananaskis G8 Summit, Toronto SARS incident, and the 2010 Olympics. He assisted the town of High River in its flood recovery communications program and recently spent two weeks in Chilliwack BC developing their post flood communications program.

He assisted the US Department of Homeland Security in establishing their social media program and established the crisis communications program for the United Arab Emirate Nuclear Regulation Agency in Adu Dhabi.

AND WHEREAS in accordance the Act and the By-law, several of the proposed amendments require approval by a Special Resolution of Members.

Sgt (Ret'd) Arnold Parris can express his experience joining the Canadian Armed Forces (CAF) in a few words, "It was the best decision I ever made!"

As a young man, Parris was always interested in joining the military. His inspiration to join the Army never wavered despite being warned off by some stating that it was not a good environment for a young Black man. However, after being urged on by a Veteran from the Vietnam War, Parris joined the Army reserves in 1978 and subsequently full-time service in 1983.

Parris' experience as a Black member of the CAF was

the opposite of what some people had told him. Within the ranks, he found community, comradeship, a sense of purpose and, most importantly, family. He wasn't oblivious to the fact that racism was present, but he wasn't going to allow the actions of a few tarnish his new found life as a Canadian soldier.

After basic and trades training as an infantryman, Parris joined the Second Battalion Princess Patricia's Canadian Light Infantry (2PPCLI). He was immediately impacted by how soldiers performed together under duress, especially in the field. His first overseas duty was in CFB Baden-Sollingen, in what was then known as West Germany.



Parris excelled in the physical aspect of soldiering, and when given the opportunity to serve in the Canadian Airborne Regiment, he took it. He served two tours, 1988 until 1992 and then again in 1994. Being a paratrooper was the highlight of his career – Germany was good, but this was better.

Amongst his medals for the various overseas tours, The Special Service Medal with NATO Bar, the United Nations Protection Force in the former Yugoslavia (UNPROFOR), NATO Medal (BOSNIA) and the Afghanistan Campaign Star.

He is the recipient of the Canadian Peacekeeping Service Medal (CPSM), the Canadian Forces Decoration (CD) with two clasps, the Canadian Forces Sacrifice Medal. He has received two Commander-in Chief Unit Commendations, 2 PPCLI Battle Group for their actions in Croatia and 3 PPCLI Battle Group for actions in Afghanistan.

Parris reflects fondly on his time in the CAF. One of his postings was as a recruiter, and his role was to create awareness of the different employment opportunities within the CAF in visible minority communities, specifically young Black men and women. He would say that "It's the best kept secret," and echoing the sentiment of the



Veteran who urged him on, "Join now! And when you do, regardless of what happens – don't quit!" Great advice from such a distinguished soldier.

Col (Ret'd) Bill Minnis

It is with great sadness we announce the sudden passing of William Hiram "Bill" Minnis of Mt Buchanan, PEI on Wednesday, December 22, 2021, in Merida, Mexico at the age of 82.

Bill is survived by his wife Brenda (Coles); his sons, Shawn (Kellylee), Mike (Goldie), William (Tara), and Mark (Kelly); his grandchildren, Elizabeth (Paul), Cassandra (Thomas), Mathew, Carmen, and Connor; and two great grandchildren, Addison and Olivia. Bill was the eldest son of Hiram and Mona Minnis.

If ever there was a soldier's soldier it was Colonel Bill Minnis. Married to his lifelong partner Brenda, they left their mark throughout the USA, Vietnam, Canada, Europe and Middle East. He was commissioned as a Second Lieutenant in 1959 in the Queen's Own Rifles of Canada. By 1979, he was a Lieutenant-Colonel commanding the Second Battalion of the Princess Patricia's Canadian Light Infantry in Winnipeg. It is said soldiers follow their leader just because he is the boss. However, in Bill's case they followed him because they respected his leadership example, admired him, and would follow him to hell and back if that is what he wanted. Bill spent the remainder of his 36-year career in Europe and the Middle East at demanding positions

with NATO and the United Nations. During the culmination of his career, he served Canada so very well as the Military Attaché with his intimately involved spouse Brenda. During his time in Israel, he was on the receiving end of SCUD missiles launched from Iraq during Gulf War One. It is well known just for spite they observed the incoming munitions accompanied by some embassy staff from the nightly happy hours arranged on the roof of the Canadian Embassy - when many others determined the basement was a better option.

As this is the 75<sup>th</sup> Anniversary of the PPCLI Association, I am providing the following article on the history of the Atlantic Branch.

# A Brief History of the Atlantic Branch by Jamie Reid

(Updated 17 Jan 1997 and Revised by Glen Ryan 07 Feb 2021)

In 1979 Lieutenant Colonel Art Neadow, then stationed in Base Gagetown, concluded that there were enough retired Patricias in the area to start a Maritime Branch of the Association. To this end he organized several meetings of both retired and serving Patricia's to lay the groundwork for an Association.

This brief history purports to outline the early years of the Association in the Maritimes. One early change was the designation change from the "Maritime" to "Atlantic" as the Association covers the four Atlantic Provinces.

As in many organizations the early files are sketchy and, in some cases, incomplete. Every effort has been made to be as factual as possible. In any event I accept full responsibility for any errors or omissions which may occur.

A series of meetings were held during 1980 with both executive and members attending to attempt to define the purpose and future activities of the members. During this period, the initial constitution and bylaws were rewritten to better reflect reality.

It was evident early on that with a member base as diverse as the far reaches of Cape Breton to the North Shore of New Brunswick the normal or usual monthly or bimonthly meetings would not work. The big problem was to design a yearly program that would be supported by the members.

It was also evident early on that close liaison with the "French Grey" Battalion of CFB Gagetown worked to the benefit of both the Association and the Patricias at the Base. I should explain the "French Grey" is rather unique. Origin of "French Grey": The Regimental full-dress uniform "facings" collar, cuffs and shoulder straps of the tunic are "French Grey". The choice of "French Grey" colour was made for two reasons:

#### **Atlantic Branch**

- To commemorate the occasion when the Regiment first went into the line alongside the French Army (06 January 1915); and
- 2) In honour of the 3<sup>rd</sup> Canadian Division with which the Regiment served during World War 1 (22 December 11 November 1918). The colour of the division patch was "French Grey".

All the Patricias stationed in Base Gagetown form a shadow unit the "French Grey" with the senior Patricia as CO with a headquarters, companies, etc. This allows them to maintain their Regimental identity and helps communication with Regimental Headquarters. Currently in the Constitution the CO of the "French Grey" is a member of the Association Executive and the Secretary-Treasurer of the Association sometimes is a member of the "French Grey". The Association members are invited to all "French Grey" "occasions" and the Association reciprocates in kind. The Association members appreciate the chance to meet serving Patricias and serving members don't object to the "war stories" of the old guard.

After several lean years in the 1980's a meeting formula was established which meets the requirements of our widely scattered members and which is supported by the members.

The Association now holds two scheduled meeting each year. The first meeting is the business meeting of the Association held in Fredericton and planned in conjunction with the "French Grey" for the same weekend they hold their Regimental Birthday celebrations. The Association members attend their business sessions

during the day and then attend the "French Grey" parties during the evening. A few of the more <u>adventuresome</u> play broom-a-loo with the "French Grey".

Spouses and "friends" of members are encouraged to participate in all activities of the Association. Spouses who are Associates Members have voting rights.

The second meeting is advertised as strictly social and is held in the fall at various locations in Atlantic Canada. The Nova Scotia (Annapolis Valley) Patricia's organized the first (1990) get-to-gether and set the standard for all future such meetings. These meetings have been highly successful and most enjoyable.

In March 1996, there was a change made in the number of meetings per year. It was agreed that there would only be one meeting in the fall and it would combine the business meeting and social event.

This brief history does not attempt to recount many of the activities which took place during the period 1980 – 1996, nor does it attempt to name members who were the driving force in making the Association successful. Many members in the provinces of the Atlantic were very directly involved in the activities and I hesitate to name any for fear of missing those who well deserve mentioning.

On the 9<sup>th</sup> of December PPCLI Association Member Retired General Ray Crabbe and Manitoba NW Ontario Branch President Perry Batchelor had the privilege of traveling to Shilo Manitoba and presented the Battalion with a Korean War Painting, Painted by James Keirstead a Korean War Veteran. What follows is an excerpt of Retired General Crabbe's Presentation Speech.



- We are very grateful for the invitation to join the 2<sup>nd</sup> Battalion today to present a wonderful painting to the Regiment and the Battalion. This painting is representative of the outstanding service of 2<sup>nd</sup> Battalion in Korea and was initiated by PPCLI Korean War Veterans to acknowledge the 2<sup>nd</sup> Battalion's unparalleled performance in Korea most notably of course, at the battle of Kapyong. We are here today to present the painting on their behalf and on behalf of all others who contributed to the purchase of this wonderful piece of art.
- The project was a close collaboration between many Korean War Veterans and others who have served in the Regiment. It was spearheaded by veteran Vincent Courtenay, a personal friend of the artist, James Keirstead. Vince encouraged him to paint a canvas that would symbolize and memorialize, Canadian soldiers and Patricias who served in Korea.
- The painting is based on a wartime photograph that shows Major George Flint, leading "A" Company of the 2<sup>nd</sup> Battalion along the high ridges of Korea in April 1951, in pursuit of the enemy. Mr. Keirstead named the painting, simply, "2 PPCLI in Korea". That's all that needs to be said.
- Early financial support was provided by Vince Courtenay, and Kapyong veterans Ted Adye and Ron Bourgon, both of whom served in Major Flint's A Company, 2 PPCLI in Korea. also joining with them were Kapyong Veterans Mike Czuboka, Bill Chrysler and Romeo Daly.

- Others who joined early to greatly assist in getting the project financed, include Patricia veterans David Diamond, and Peter Remdenok, who served with the Electrical and Mechanical Engineers and attached to the Regiment at the time. Once word spread about this project, volunteers from the Regimental Association and others would join in and the project was fully financed in no time.
- Although he is too humble to take credit, it was through veteran Vince Courtney's imagination, talent, and selfless contribution, that one of the most significant commemorative military projects in Canada in recent years was brought to fruition that is, this painting of the Patricias in Korea by one of Canada's most renowned artists.



#### The Artists James Keirstead's Comments

"This painting was my first oil painting of war. I had thought about painting war scenes ever since Korea where I was a Service Corps ambulance driver from 1952 to 1953.

My few days at the front were in 1952 when a night patrol of the PPCLI was sent out, resulting in seven Patricias being killed and 16 men wounded. I evacuated several of these soldiers.

In my dealings with the PPCLI, I have found all of you to be truly special people. You make us Canadians very proud. I see your motto – Once a Patricia Always a Patricia - is proudly lived up to.

*Thanks to all who contributed to the purchase of the painting – especially the veterans of the Korean war.* 

Sadly, I have been unable to paint since June of this year, as I am still in recovery."



It has been a tough couple of years, as an Association we hope that you all got through it without too much hardship. Many of us lost friends due to covid or other illness. I sincerely hope we are through it and we can move on to the "new normal".

Now our attention turns to the Ukraine, the images on the news will trigger many. As I said Saturday Night, if you need help reach out. Take care of yourselves and each other. VP



Major (Ret'd) Murray Edwards

Former PPCLI Major (Ret'd) Murray Edwards, celebrated his 102<sup>nd</sup> birthday at the Broadmead Lodge in Victoria on January 16<sup>th</sup>, 2022. The oldest surviving veteran of 2 PPCLI at the battle of Kapyong in April 1951, he was delighted to receive news that his late comrade in in arms, Lt Mike Levy, had been formally recognized for his gallantry by the 2020 inclusion in the PPCLI Regimental Manual (THE KOREAN WAR 1950-1953) and also, the Embassy of Canada to Korea / DND 2021 publication "KAPYONG 70", page 70. These two acknowledgements along with the Canadian Encyclopedia's 2020 revised version of the battle, help to fulfill Murray's personal quest and those of other survivors of the battle whose lives were saved by Lt Mike Levy's courageous and selfless actions, under threat of immediate annihilation.

Lt Mike Levy was the originator of the Danger Close artillery fire request. He then monitored and directed the barrage from his 10 Platoon's position / target area under close attack, on the knob of Hill 677, during the morning of April 25, 1951. This forty-minute 25 pounder gun shelling by the 16th Field Regiment, Royal New Zealand Artillery, was so effective it halted the advance of the overwhelming enemy without casualties to the hunkered down 10 Platoon. In doing so it is accepted that Seoul was saved as was the 27th British Commonwealth Brigade from defeat at the hands of the thousands of advancing Chinese Communist Forces destined to break through the United Nation's defence of the valley.

In appreciation of the gallant stand by 2 PPCLI at KAPYONG, the battalion, along with the 3rd Royal Australian Regiment and Company A, of the 72<sup>nd</sup> US Heavy Tank Regiment, were awarded the United States Presidential Unit Citation.

Special mention on this occasion is to the late Lt. Hub Gray and his 2003 publication "Beyond the Danger Close," the 2011 documentary video "KAPYONG" produced in Australia, and to Murray Edwards for his dedication and perseverance in his quest.

#### The United Kingdom Branch

We did plan to use one of the group photos from the remarkable collection of Regimental memorabilia of Ida Schjelderup, widow of Col Roger Schjelderup and long-time Social Secretary of the UK Branch, for this
